EXPLANATORY STATEMENT:

The Company, being a listed company, will have to appoint a Secretarial Auditor u/s 204 of the Companies Act, 2013, to audit the secretarial records of the Company for the year ended 31st March 2024. As per the amended provisions of Regulation 24A of SEBI (LODR) Regulations, 2015, listed entities shall additionally, on an annual basis, require a check by the PCS on compliance of all applicable SEBI Regulations and circulars/guidelines issued thereunder, consequent to which, the PCS shall submit a report to the listed entity in the manner specified in the circular. The Annual Secretarial Compliance report in the prescribed format shall be submitted by the listed entity to the stock exchanges within 60 days of the end of the financial year. Further, as required under section 92 of the Companies Act, 2013, the Annual Return to be filed by the Company for the year ended 31.3.2023 will have to be certified by a Practising Company Secretary. The Managing Director will brief the Board in this regard at the meeting. The Board may consider the recommendation of the Audit Committee in this regard and appoint a Secretarial Auditor for issuing Secretarial Audit Report u/s 204 of the Companies Act, 2013, and an Annual Secretarial Compliance Report under regulation 24A of the SEBI (LODR) Regulations, 2015, and to certify the annual return to be filed by the company for the year ended 31.3.2024 to be filed with the Ministry of Corporate Affairs for the year ended 31.3.2024.
