Further, as required under section 92 of the Companies Act, 2013, the Annual Return to be filed by the Company for the year ended 31.3.2023 will have to be certified by a Practising Company Secretary The Managing Director will brief the Board in this regard at the meeting. The Board may consider the recommendation of the Audit Committee in this regard and appoint a Secretarial Auditor for issuing Secretarial Audit Report u/s 204 of the Companies Act, 2013, and an Annual Secretarial Compliance Report under regulation 24A of the SEBI (LODR) Regulations, 2015, and to certify the annual return to be filed by the company for the year ended 31.3.2024 to be filed with the Ministry of Corporate Affairs for the year ended 31.3.2024.
