FLIGHT TO FREEDOM...

It is learnt that the Emir ordered the release of the eight Indians. The Navy veterans apparently faced charges of espionage, but neither the Qatari authorities nor New Delhi made the charges against them public.

In 2 brief months... He added that the government is planning to start helicopter facilities from Indore to Ujjain and Omkarnagar before imposition of the Model Code of Conduct in view of the Lok Sabha elections.

Comfortable win for... As many as 43 Janata Dal (United) MLAs, 78 Bharatiya Janata Party MLAs, four Hindustani Awam Morcha legislators, an independent MLA and three RJDM MLAs voted in favour of the motion.

Industrial output... In August 2023, inflation touched a high of 6.83 per cent. According to the data released by the National Statistical Office (NSO), retail inflation in the food basket was at 8.3 per cent in January 2024, down from 9.53 per cent in the preceding month.

Sonia in RS... For Priyanka Gandhi Vadra, whose entry in electoral politics has been speculated on for decades, this is seen as a safe seat. The constituency, a Congress bastion since 1950s, was first represented by her grandfather Feroze Gandhi. It was expected that Mr. Gandhi Vadra would contest in the constituency formally entered politics in January this year. Many had hoped for a face-off between her and Prime Minister Narendra Modi in Varanasi.

Talks fail, farmers... In the meeting, the Centre is learnt to have agreed to withdraw the cases against the farmers registered during the 2020-21 agitation, sources said. The ministers -- Food and Consumer Affairs Minister Piyush Goyal and Agriculture Minister Anurag Thakur -- held the second round of talks with the farmer leaders at the Mahatma Gandhi State Institute of Public Administration in Sector 26.

Deep fakes, GenAI... Celebrity impersonations, particularly targeting older demographics, have become widespread. These scans often originate on platforms like Facebook, tricking recipients into a false sense of security, the report mentioned. "A troubling trend emerging is one where scammers routinely target older individuals, especially those who are widowed or suffer from memory loss," the report added.

Tamil governor ends address to Assembly in minutes

CHENNAI: In yet another instance of his confrontation with the DMK dispensation in Tamil Nadu, Governor N. Ravin on Monday concluded his customary address to the House within a few minutes, making certain remarks over the content of the address that were 'expunged'.

As Ravi made some mention about the national anthem, Speaker M. Appavu said it is played at the House on the day when the Governor delivers his customary address, and cited House rules in this regard. In a statement later, the Raj Bhavan alleged Ravi's advice to the Tamil Nadu government to show due respect to the national anthem and play it at the beginning and end of the Governor's customary address to the Assembly was ignored by the DMK regime.

It also alleged the Speaker launched a tirade in the Assembly against the Governor and called him a 'follower of Netharam Goswami and hence Ravi', with due regard to the dignity of his office, left the House. After Appavu raised the issue of flood relief to the state and made some remarks, the Governor walked out of the House, before the national anthem was played for the day. In the history of the Tamil Nadu Legislative Assembly, this is the first time a Governor has not read out his customary address to the House at the start of the session for a year.

Last year on January 9, Ravi omitted some portions of the government prepared address and also included some points on his own. This was Ravi's inaugural address for the year.

In a debate during the Question Hour of the ongoing budget session, state Education Minister Kuber Dindor admitted that the number of schools facing a shortage of teachers has increased in the last two years mainly because of the transfer of educators to places of their choice.
