***Re: Rating of Commercial Paper programme of LT Foods Limited***

**This is in reference to the rating action commentary released on 30 November 2023.**

India Ratings and Research (Ind-Ra) is pleased to communicate the rating of 'IND A1+' for the INR500 million Commercial Paper Programme of LT Foods Limited.

In issuing and maintaining its ratings, India Ratings relies on factual information it receives from issuers and underwriters and from other sources India Ratings believes to be credible. India Ratings conducts a reasonable investigation of the factual information relied upon by it in accordance with its ratings methodology, and obtains reasonable verification of that information from independent sources, to the extent such sources are available for a given security.
