Sub: Amendment of Central Motor Vehicles Rules, 1989

This is with reference to regulation 30 and other applicable regulations of SEBI (Listing Obligations & Disclosure Requirements) Regulations, 2015; we give below an update/press release:

New Delhi December 11, 2023: This is further to our update dated 12th July, 2023 where it was informed that the Ministry of Road Transport and Highways, Government of India has issued draft rules, inter alia, that the vehicles of N2 and N3 category manufactured on or after 1st January 2025 shall be fitted with an air-conditioning system for cabins. In this regard, this is to inform that Ministry of Road Transport and Highways, Government of India vide notification dated 8th December, 2023 has amended the Central Motor Vehicles Rules, 1989; mandating that the vehicles manufactured on or after 1st October, 2025 shall be fitted with an air-conditioning system for cabins of N2 category (3.5 tonnes and above but less than 7.5 tonnes Gross Vehicle Weight) and N3 category (7.5 tonnes and above Gross Vehicle Weight).This may have incremental business opportunities to the vehicle air-conditioning components manufacturing companies.
