1. The brief particulars of the Scheme of Reduction in Capital are as mentioned below:

I. The Scheme of Reduction of Capital of the Company was approved by Hon'ble National Company Law Tribunal, New Delhi Bench, vide order dated September 12, 2023.

II. As per the Scheme of Reduction, the issued, subscribed and paid-up share capital of the Company shall stand reduced from Rs. 11,33,00,000/- comprising of 1,13,30,000 equity shares of Rs 10/- to Rs. 6,79,80,000/- comprising of 67,98,000 equity shares of Rs. 10/- each.

2. As per Exchange Notice No. 20231004-25 dated October 04, 2023, the Company had fixed October 04, 2023, as record date for giving effect to the reduction of share capital.
