<u>Re: 'In-principle' approval under Regulation 28(1) of the SEBI (Listing Obligations and Disclosure</u> <u>Requirements), Regulations, 2015.</u>

We refer to your application seeking our "In-principle approval for the issue of 38,77,000 equity shares of Rs.2/- each at a price not less than Rs. 346/- to non-promoters on a preferential basis."
