- 1. Approved alteration in articles of associations of the Company.
- 2. Approved to issue and allot up to 10,60,000/-(Ten lakhs Sixty Thousand only) warrants convertible into equivalent number of Equity Shares of face value of Rs. 10 each in accordance with the applicable laws ("Warrants") at a price of Rs. 311/- (Rupees Three Hundred and Eleven only) each (including the warrant subscription price and the warrant exercise price) aggregating up to Rs 32,96,60,000/ (Rupees Thirty Two Crores Ninety Six Lakhs Sixty Thousand Only) to the Promoter/ Promoter Group and non promoter entity (as listed in Annexure I herein) by way of preferential issue in accordance with the provisions of Section 62(1)(c) of the Companies Act, 2013, as amended ("Act") read with Companies (Share Capital and Debentures) Rules, 2014 as amended ("Rules"), Chapter V of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018, SEBI (LODR) Regulations, 2015 and such other acts / rules / regulations as may be applicable and subject to necessary approval of the members of the Company and in principle approvals of the stock exchanges and other regulatory authorities, as may be applicable in this regard.
- 3. Approved to issue secured unlisted redeemable Non Convertible Debentures (NCDs) upto Rs. 50 cr. (Rupees Fifty Crores only) in one or more tranches/series on private placement basis.

The Company will be seeking approval of the shareholders for the proposed aforesaid businesses alongwith other businesses by convening an Extra Ordinary General Meeting subject to applicable provisions/circulars issued by Ministry of Corporate Affairs and SEBI from time to time.
