## DMR Business Performance Update - FY23-24

Faridabad, India – April 25, 2024 – DMR, a leading engineering consulting company in the field of infrastructure, announced today its financial results for the Second Half and Full Year ended 31st March 2024 (consolidated).

#### Key Financial Metrics: Full Year (April 2023 – March 2024)

- Revenue increased by 64.8% year-over-year to ₹7.36 crores
- EBITDA at ₹2.35 crores. EBITDA margin at 32%
- Profit after tax increased by 99.1% year-over-year to ₹1.53 crores. Profit after tax margin at 20.8%
- Earnings per share increased by 97.4% year-over-year to ₹4.08
- Cash & Cash Equivalents at ₹3.88 crores

#### **Significant Events During the Financial Year**

- Our order book as of 31<sup>st</sup> March 2024 stands at Rs. 13.5 crores.
