Four held for cheating bank in Palghar of Rs 29 lakh

Palghar, Nov 10 (PTI) : The number of persons arrested for allegedly cheating a bank in Palghar district to the tune of Rs 29.29 lakh reached four after a man was held from Pune's Pimpri Chinchwad, a police official said on Friday.

Between February 2018 and September 2021, four persons had obtained a housing loan of Rs 29.29 lakh by submitting fake documents, and a case was filed at Arnala Sagri police station after the lender came to know about the fraud, said Crime Branch Unit III senior inspector Pramod Badakh.

He said Deepak Shukla, the fourth accused in the case, was held from Pimpri Chinchwad on November 8.

LCB police seize Goa made foreign liquor, truck total valued Rs 69.60L

Kolhapur, Sindhudurg, Nov 10 (UNI) : Local Crime Branch of Sindhudurg district Friday seized Goa made foreign liquor and a truck, total value Rs 69.60 lakh at Wargaon rpt Wargaon on Mumbai-Goa national highway in Sindhudurg district on Friday morning.

In an official press statement Friday, while patrolling on Mumbai-Goa

national highway, LCB team found a suspicious truck, which was parked at the front of Rajdhani Dhaba on highway at Wargaon. After search, LCB found total 1200 boxes of Royal Blue brand whisky, valued of Rs 57.60 lakh. Police also seized truck valued Rs 12 lakh. No one came forward for claiming the truck so far.

Police are investigating further.

Ex Governor P B Acharya passes away in Mumbai

Mumbai Nov 10 (UNI) : Senior BJP leader and former Governor Padmanabha Balakrishna Acharya, popularly known as P B Acharya passed away at his residence in Juhu on Friday.

He was 92. Born in Udupi in coastal Karnataka on October 8, 1931, Acharya served as the Governor of Assam, Manipur, Nagaland, Arunachal Pradesh, and Tripura between 2014 and 2019. He had held various positions in the Bharatiya Janata Party (BJP) before becoming governor.

In 1980, P.B. Acharya joined the Bharatiya Janata Party. He was elected the BJP President of North West Bombay District in 1987 and later in 1989 became a committee member of the Mumbai BJP.

In 1991, he was elected as National Executive member of BJP and in charge of the North Eastern States namely, Arunachal Pradesh, Manipur, Meghalaya, Mizoram and Nagaland.

Drought-like situation declared in 178 talukas of Maha: Minister

Mumbai, Nov 9 (UNI) : Besides having declared drought in 40 talukas of the state, the Maharashtra government has declared a drought-like condition in remaining 959 revenue circles of 178 talukas, which had received less than 75 per cent rainfall during this monsoon season. Presiding over a Cabinet Sub-Committee meeting here, Relief, Rehabilitation and Disaster Management Minister Anil Patil announced that these revenue circles will be given all concessions applicable to the drought-hit areas.

He said that drought has been declared in 40 talukas

as per the criteria of the central government.

However, keeping in mind the low rainfall received in some circles of the remaining talukas in the state, drought-like condition has been declared in 959 revenue circles of 178 talukas, he said. The minister said that concessions such as non-disconnection of electricity to farmers' agricultural pumps in the villages where shortage has been declared will be extended in 959 revenue boards.

Patil also said that five lakh tonnes of chicken grass will be produced and distributed to one lakh beneficiary farmers in the state to produce fodder for their livestock.

Over 87% votes cast in Mizoram repoll

Aizawl, Nov 10 (UNI) ; Re-poll in a polling station for the Mizoram Assembly election passed off peacefully with 87.08 percent of the voters exercising their franchise on Friday. The repoll in the Muallungthu polling station within Aizawl South-3 assembly constituency became necessary as officials forgot to erase the mock poll results from the EVM and those got added to the actual votes.

Officials said 944 (484 female and 460 male voters) out of the total 1,084 voters exercised their franchise in the re-poll.

This is the only polling station in the state where re-polling has been conducted after the state went to the hustings on Tuesday to elect a 40-member state Legislative Assembly.

Re-poll was necessitated after the polling officials of Muallungthu polling station realised that votes, polled in the mock poll, before the actual polling began

at 7 AM on Tuesday, were not deleted and that the electorate continued to cast their votes in the same electronic voting machine (EVM).

The returning officer of the polling station, after consulting the election observer, notified the matter to the central poll panel and the ECI ordered the re-poll.

A new set of polling officials were appointed to conduct the re-poll. Four candidates - Rosiamgheta from

Congress, Prof F Lalnunmawia from ruling Mizo National Front, Baryl Vanneihnsangi from Zoram People's Movement and Rev Zaichhawna Hlawndo, an independent - are contesting from Aizawl South-III.

In 2018, F Lalnunmawia wrested the seat from K S Thanga, of Congress, by securing 7,558 votes, which was 43.47% of votes polled.

Goa made foreign liquor seized on Mumbai, Goa NH

Sindhudurg, Nov 10 (UNI) : The local Crime Branch of Sindhudurg district on Friday seized Goa made foreign liquors and a truck, a total value Rs 69.60 lakh at Wargaon on Mumbai-Goa national highway in Sindhudurg district.

Patrolling on Mumbai-Goa national highway, LCB team found a suspicious truck, which was parked in front of Rajdhani Dhaba.

After search, they found 1200 boxes of Royal Blue brand whisky, valued Rs 57.60 lakh and seized a truck valued Rs 12 lakh. No one has come forward to claim the truck so far, police said in a statement.

Two held for stealing mobile phones in Latur

Latur, Nov 10 (PTI) : The police in Maharashtra's Latur district arrested two persons for allegedly stealing mobile phones and recovered 10 devices from their possession, an official said on Friday.

Acting on a tip-off, the police nabbed the accused Saudagar alias Saudya Hajare (20) and Ravi Kasbe (19) while they were trying to sell the stolen mobile phones at AUSA Road, he said.

The police have recovered 10 mobile phones and a motorcycle worth Rs 1.60 lakh from the duo, the official said.

Senior official of pharma firm booked for culpable homicide for fire that killed 11 at Raigad factory

Mumbai, Nov 10 (PTI) A senior official of pharmaceutical firm Blue Jet Healthcare has been booked for alleged culpable homicide following the death of 11 persons in a fire at its factory in Maharashtra's Raigad district, police said on Friday.

While the senior official who was responsible for the plant's maintenance was arrested three days ago, two others have also been named in the case, an official said.

A blaze broke out at the company's plant at Mahad MIDC, 170 km from here, on November 3. Eleven persons were killed and seven were injured in the incident.

Brown sugar worth over Rs one crore seized in Odisha
