New Delhi, March 14 (IANS) Reliance Industries has signed an agreement to acquire 13.01 per cent equity stake of Viacom 18 Media Private Limited (Viacom18) held by Paramount Global through its two subsidiaries for an aggregate consideration of Rs 4,286 crore.

Viacom18 is a material subsidiary of TV18 Broadcast Limited. Reliance Industries currently holds Compulsorily Convertible Preference Shares of Viacom18 representing 57.48 per cent equity stake (on a fully diluted basis).

Post the completion of this transaction, Reliance Industries equity stake in Viacom18 will increase to 70.49 per cent (on a fully diluted basis). The acquisition is not a related party transaction and none of the company's promoter/promoter group/group companies have any interest in the acquisition, Reliance Industries said in a filing.

On February 28, RIL, Viacom 18 Media and The Walt Disney Company (Disney) announced the signing of binding definitive agreements to form a joint venture (JV) that will combine the businesses of Viacom18 and Star India.

As part of the transaction, the media undertaking of Viacom18 will be merged into Star India Private Limited (SIPL) through a court approved scheme of arrangement. In addition, RIL has agreed to invest at closing Rs 11,500 crore (\$ 1.4 billion) into the JV for its growth strategy.



Rajasthan creates new record in auctioning major mineral blocks

Jaipur, March 14 (IANS) Rajasthan has set a new record in the auction of major mineral blocks under the current BJP government, confirmed officials.

The Mines and Geology Department of Rajasthan has successfully auctioned 31 major minerals blocks through the Government of India's e-portal till March 13, said state Mines Secretary Anandi on Wednesday, adding that 15 blocks of limestone have been successfully auctioned in just 22 days.

According to the progress report released from the Mines Ministry, 22-22 major mineral blocks were auctioned each in Madhya Pradesh and Rajasthan till March 1 in this financial year. Soon after, with the



which is the highest in the country.

In the last financial year, a maximum of 29 blocks were auctioned in Madhya Pradesh and 20 in Chhattisgarh, whereas in Rajasthan only eight blocks of major minerals were auctioned last year, which was the highest after the new provisions were introduced. Last year, 105 major

mineral blocks were auctioned across the country. Maximum 25 mineral blocks were auctioned in Odisha in 2019-20. Mines Secretary Anandi said that the Central government is also emphasizing on auctioning blocks of major minerals and the states are being asked to prepare and auction as many mineral blocks as possible and it is being monitored.

She said that the preparation and auction of mineral blocks is reviewed monthly in 13 states of the country, including Rajasthan. As soon as the new government was formed, Chief Minister Bhajanlal Sharma, who is also the Mines Minister, gave instructions to run a campaign to curb illegal mining, and laid emphasis on preparing as many blocks as possible for auction so that legal mining can be promoted. Hyundai, Kia to recall 1.7 lakh EVs over charging software issue

Seoul, March 14 (IANS) Hyundai Motor and Kia will voluntarily recall nearly 170,000 electric vehicles (EV) to address a software error in the charging system, the government said on Thursday. The Ministry of Land, Infrastructure and Transport said 12 car models totaling 232,000 units from Hyundai Motor, Kia, Stellantis Korea and Tesla Korea are subject to recall due to manufacturing defects. Of those, 169,932 Hyundai Motor and Kia units were found to have software errors in the integrated charging control unit. Models affected are Hyundai's Ioniq 5, Ioniq 6, Genesis GV60, GV70 and GV80 EVs, totaling 113,916 units, and 56,016 units of Kia's EV6, reports Yonhap news agency. The ministry said that the error could prevent the vehicles in question from conducting low-voltage charging, leading to the possibility of the vehicles stopping while driving.
