We are pleased to present the report on the Postal Ballot conducted by The New India Assurance Company Limited ("the Company") seeking consent of its Members for the Resolutions as contained in the Notice of Postal Ballot dated 09th February, 2024.

- 1. In terms of provisions of Section 110 of the Companies Act, 2013 ("the Act") read with Companies (Management and Administration) Rules, 2014, we were appointed as the Scrutinizer by the Company on 09th February, 2024 to conduct the Postal Ballot as contained in the Notice dated 9th February, 2024 ("Postal Ballot Notice").
- 2. In terms of Sections 110 and 108 of the Companies Act, 2013, and all other applicable provisions, if any, of the Act read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 and in accordance with the relevant circulars issued by Ministry of Corporate Affairs (MCA) from time to time, in relation to "Clarification on passing of Member's resolution by companies under the Companies Act, 2013" read with rules made thereunder, Members' approval was sought for the Resolutions as contained in the Postal Ballot Notice through e-voting only.

3. Notice of the Postal Ballot.

3.1. The Company has informed that, on the basis of the Register of Members and the List of Beneficial Owners made available by the Depositories viz., National Securities Depository Limited (NSDL) and Central Depository Services (India) Limited (CDSL), as on 08th March, 2024 ("the cut-off date"), the Company had completed the dispatch of Postal Ballot Notice on 14th March, 2024 through e-mail to 1,38,029 Members who had registered their email-IDs with the Company/ Depositories/ Depositary Participants/ Registrar and Share Transfer Agents (RTA).

- 3.2. The Company had hosted the Postal Ballot Notice on its website and the website of National Securities Depository Limited ("NSDL") (e-voting Agency) and also intimated the same to BSE Limited and National Stock Exchange of India Limited on 14th March, 2024.
- 3.3. Pursuant to Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014 and the relevant MCA Circulars, an advertisement regarding the Postal Ballot was published on 15th March, 2024 in all editions of Financial Express (English Newspaper) and in Jansatta (Hindi Newspaper) and in Loksatta (Marathi Newspaper).
- 4. In terms of the aforesaid notice, Members were required to convey their assent or dissent, only through e-voting system, on e-voting platform provided by NSDL from 9:00 a.m. (IST) on Thursday, 21st March, 2024 to 5:00 p.m. (IST) on Friday, 19th April, 2024.
- Member's demographic details and voting rights were downloaded by us from e-voting platform provided by NSDL.
- 6. After the scrutiny of the votes cast file downloaded from e-voting platform provided by NSDL:
 - 6.1. We found that all the votes cast by the Members were valid; and
 - 6.2. We report that 02 (Two) Special Resolutions as contained in the Postal Ballot Notice have been passed with requisite majority.


