Pursuant to Regulation 30 read over with Sub Para 14 of Para A of Part A of Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, Para A(14) of Annexure I of SEBI Circular No. CIR/CFD/CMD/4/2015 dated September 9, 2015, Circular no. SEBI/HO/CFD/PoD2/CIR/P/2023/120 dated July 11, 2023 and Para A(14) of Annexure I of Circular no. The existing Clause "5<sup>th</sup>" of the Memorandum of Association of the Company has been altered and amended by replacing the same with the following new Clause as under:-

"5th. The Share Capital of the Company is ₹ 10,50,00,000/- (Rupees Ten Crores Fifty Lakhs only) divided into 1,05,00,000 (One Crore Five Lakhs) Equity Shares of ₹ 10/- (Rupees Ten Only) each."
