Introduction

- 1. - 2 The Company's business segment consists of a single segment of "trading in commodities and other commodity related activities" in accordance with Ind AS 108 'Operating Segments' notified pursuant to the Companies (Indian Accounting Standard) Rules, 2015.
- During the quarter ended 30th June 2022, the company executed necessary definitive agreement on 29th April, 2022 for sale of 'assets held for sell' comprising the assets of Jolwa Manufacturing Division including all specified tangible assets, i.e. land, building, plant and machineries and other assets to the Garden Silk Mills Private Limited and recognised the Profit from sale of the said assets as 'profit from discontinued operation' for the year ended 31st March, 2023.
- 4 The Company does not have any Exceptional item to report in above periods.
- The above financial results have been reviewed and recommended by the Audit Committee and approved by the Board of Directors of the Company at their respective meetings held on 13th February, 2024 and have undergone 'Limited Review' by the statutory auditors of the Company. The statutory auditors have expressed an unmodified conclusion on these unaudited financial results.
