Re: Continuous Disclosure Required under SEBI Circular dated July 13, 2023, for Corporate Announcement filed under Regulation 30 of SEBI (LODR) Regulations, 2015.

We take reference to our communication TTKH:SEC:SL:330:23 dated December 07, 2023, on the above subject.

In accordance with the SEBI Circular SEBI/HO/CFD/CFD-PoD-1/P/CIR/2023/123 dated July 13, 2023, regarding the continuous Disclosure Requirement for events that are deemed material or may apply materiality in terms of Schedule III of Regulation 30 of SEBI (LODR) Regulations, 2015 we provide below the following further details:

Disruption of operations - The manufacturing facility for Ortho Implants situated at No.290, SIDCO Industrial Estate Ambattur, Chennai 600 098, Tamil Nadu was totally flooded / waterlogged and the production activities have been disrupted due to torrential rains / impact of "Michaung" cyclone.	
Regularly, till complete normalcy is restored:	
1.	Insurance amount claimed and realized by the listed entity for the loss/damage : The Insurance assessment / inspection / survey is in progress. The same will be ascertained once the exercise is completed.
2.	The actual amount of damage caused due to the natural calamity or other force majeure events : The actual amount of damage could be ascertained after Insurance assessment / inspection / survey process.

Details of steps taken to restore normalcy and the impact of the natural calamity / other force majeure events on production or service, financials of the entity	: Steps Taken: The stagnated water has been drained from the manufacturing facility; fumigation process completed and the validation of the Clean Room, etc., to be done. The drenched equipments are under repair / servicing. Production is expected to be resumed within the next 10 days. Impact: There has been loss of production for 5 days as of now and the exact financial impact is being ascertained.
