**Sub.: Submission of the results of the Postal Ballot**

Pursuant to Section 110 of the Companies Act, 2013 read with Rule 20 and 22 of the Companies (Management and Administration) Rules, 2014, Regulation 30 read with Schedule III of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 and in furtherance of our intimation vide letter dated February 29, 2024 of the Postal Ballot Notice dated February 29, 2024 sent to the shareholders of the Multibase India Limited (“the **Company**”) as on the cut-off date Friday, February 23, 2024, seeking their approval for the following business as Special Resolutions:

Dear Sir,

I, Rishit Deepak Shah (M. No.: F9522, C.O.P.: 26870), Company Secretary in Practice and Founder of Rishit Shah & Co., Practicing Company Secretaries, have been appointed as the Scrutinizer by the Board of Directors of Multibase India Limited ("the Company") in their meeting held on February 12, 2024 for the purpose of scrutinizing the voting by means of Postal Ballot through remote e-voting process ("e-voting") in a fair and transparent manner on the resolutions contained in the Postal Ballot Notice dated February 29, 2024 sent in accordance with the provisions of Sections 108 and 110 of the Companies Act, 2013 ("Act"), read with Rules 20 and 22 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("SEBI Listing Regulations") including any statutory modification(s) thereto or re-enactment(s) thereof for the time being in force, and other applicable provisions, if any, read with the General Circular No. 14/2020 dated April 8, 2020, General Circular No. 17/2020 dated April 13, 2020, General Circular No. 22/2020 dated June 15, 2020, General Circular No. 33/2020 dated September 28, 2020, General Circular No. 39/2020 dated December 31, 2020, General Circular 10/2021 dated June 23, 2021 and General Circular No. 20/2021 dated December 8, 2021, General Circular No. 3/2022 dated May 5, 2022, General Circular No. 11/2022 dated December 28, 2022 and General Circular No. 09/2023 dated September 25, 2023 issued by the Ministry of Corporate Affairs ("MCA") (hereinafter collectively referred to as "MCA Circulars"), applicable provisions of the SEBI



Listing Regulations as amended and Secretarial Standards – 2 on General Meetings (“SS-2”) issued by the Institute of Company Secretaries of India, and other applicable laws and regulations, if any.

The Postal Ballot Notice dated February 29, 2024 along with Explanatory Statement setting out material facts under Section 102 of the Act as confirmed by the Company were sent through electronic mode only to those Members whose e-mail addresses were registered with the Company/ Depositories.

The Company had engaged the services of National Securities Depository Limited (“NSDL”) to provide remote e-voting facility to its Members.

The shareholders of the Company holding shares as on the “cut-off” date of Friday, February 23, 2024 were entitled to vote on the resolutions as contained in the Notice.

The remote e-voting period commenced from 9:00 a.m. (I.S.T.) Friday, March 01, 2024 and ended on 5:00 p.m. (I.S.T.) Saturday, March 30, 2024 and the NSDL e-voting module was disabled thereafter.

The votes cast under remote e-voting facility were thereafter unblocked and were counted.

The votes cast during the remote e-voting period were unblocked on Saturday, March 30, 2024 after the conclusion of e-voting period for Postal ballot and was witnessed by two witnesses, Divyata Raval and Dixita Gawas, who are not in the employment of the Company and/ or NSDL.

#### **Management’s Responsibility:**

The management of the Company is responsible to ensure the compliance with the requirements of the Companies Act, 2013 read with Rules made thereunder and the applicable regulations of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, relating to remote e-voting on the resolutions as contained in the aforesaid Notice of Postal Ballot.

#### **Scrutinizer’s Responsibilities:**

Our responsibility as a Scrutinizer is to scrutinize and ensure that the voting done through remote e-voting is done in a fair and transparent manner and to make a Consolidated Scrutinizer's Report of the votes cast "in favour" or "against" the resolutions, based on the reports generated from the remote e-voting system of NSDL.



The resolutions set out in the Postal Ballot Notice are as under:

- 2. Resolution No. 2 as a Special Resolution** for appointment of Mr. Renganathan Bashyam (DIN: 01206952) as an Independent Director of the Company.

A summary of the remote e-voting is as per the “**Annexure**” annexed to this Report.

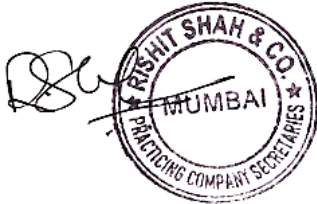
I report that the Special Resolutions as set out in Item Nos. 1 and 2 of the Postal Ballot Notice have been passed with requisite majority.

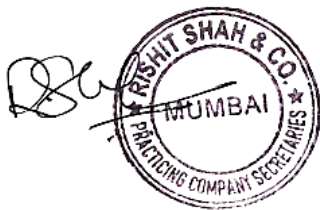
