We have reviewed the accompanying Statement of unaudited Standalone financial results of Regis Industries Limited (Formerly known as Bhartia Bachat Limited) for the quarter ended 30 September 2023 ("the Statement")' being submitted pursuant to the requirements of Regulation 33 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended (Listing Regulations').
- 2.
