Gist of Proceedings of the 57th Annual General Meeting (“AGM”) of JSL Industries Limited held on Tuesday, September 26, 2023, through Video Conferencing (“VC”) / Other Audio-Visual Means (“OAVM”).

Mr. Ravi Thanki, Company Secretary, welcomed all Members to the 57th Annual General Meeting (“AGM”) of the Company held on Tuesday, September 26, 2023, at 11:00 a.m. (IST), through Video Conferencing (“VC”) / Other Audio-Visual Means (“OAVM”) in accordance with the circulars issued by Ministry of Corporate Affairs and Securities and Exchange Board of India.

He informed that Mr. P.V. Krishnan, Director and Chairman of Stakeholders Relationship Committee had expressed his inability to attend the meeting due to personal commitments and leave of absence was granted to him. All other Directors including Chairman of Audit Committee and Nomination and Remuneration Committee were present at the meeting through VC.
