#### Slaughterhouse raided in Thane, lard seized

Thane: Civic authorities raided a closed slaughterhouse in Thane and busted an illegal manufacturing unit engaged in production of lard. The raid was conducted on Tuesday at Idgah Road in Bhiwandi. Officials found clandestine production

of fat from animal body parts for supply in the market, Bhiwandi Nizampur Municipal Corporation's disaster management officer Sakib Karbhe said. Ten tins of illicitly produced lard, six large vessels and other items were seized.



# Four train deaths in a day: Call for staggered office hrs, more trains

Two victims suspected to have fallen from overcrowded local trains during morning peak hours, while one is suspected death by suicide; govt yet to take decision on office timings

A day after four persons were killed in separate railway accidents between Kalyan and Kopar railway stations, the Dombivali Government Railway Police (GRP) have focused their attention on the pressing need for improved safety measures and infrastructure enhancements in the region.

The GRP is actively investigating the cases and have registered accidental death reports in each incident. While two victims are suspected to have fallen from overcrowded local trains during the morning peak hours, the other two were involved in train collisions, with one suspected



death by suicide.

In the first incident, at 12.30am on Wednesday, a 50year-old unidentified woman was found dead between Thakuri and Kalyan, believed to have been struck by a local train. The second mishap occurred around 8.15am when



another woman, aged between 42 and 45 years, fell from an overcrowded fast local train between Thakurli and Kalyan. The third accident, reported at about 8.45am between Kopar and Dombivli, resulted

in the death of Sushil Putran,

who fell from a local train. The fourth incident occurred at 11.15am when an unidentified person was run over by a speeding train between Dombivali and Koper. According to a GRP

official, two victims are suspected to have fallen off an overcrowded local train, but the rail authorities are yet to confirm this. The incidents have led to concerns and demands from passengers, who are advocating for changes in office timings of companies to alleviate the morning rush hour and suggesting introduction of additional suburban trains or the extension of platforms on the Thane-

Kasara/Karjat section. Somesh Shah from Dom-

bivali emphasised the need to adjust office timings to reduce morning rush hour congestion. Similarly, Jignesh Verma from Kalyan suggested extending platforms to accommodate longer trains, while Manisha Kulkarni of Dombivali said there's a need for concrete solutions

like capacity augmentation to control overcrowding. Despite efforts from the Divisional Railway Manager (DRM) of Central Railway, who sent letters to more than 750 companies in Mumbai urging them to stagger office timings, the state government, holding the power to implement these changes, has not yet taken any substantial



### Drive against ticketless travel in BEST buses: 945 held in a day

The Brihanmumbai Electric Supply and Transport (BEST) Undertaking has launched a special drive to curb ticketless travelling on its buses since the start of the New Year and caught nearly 945 passengers in a single day on January 2 and collected a fine of Rs58,457.

The civic transport body, that provides public bus services in Mumbai along with neighbouring Thane, Navi Mumbai and Mira-Bhayandar, said the fine amount collected was eight times more than the average per day penalty of Rs7,000 it used to collect before the drive. "It was the biggest crackdown against ticketless travellers after the Covid pandemic," an official said, adding that the drive will be continued in future as well.

BEST said it has deputed ticket checking 382 inspectors under the special drive and deployed smaller teams of such personnel on crowded routes in the metropolis. The civic undertaking has a fleet of around 3,000 buses that operate on different routes in Mumbai and ferry 32-35 lakh passengers daily.

If a passenger is caught travelling without a valid ticket, BEST collects 10 times regular fare as fine and takes action as per section 460(H) of the Mumbai Municipal Act, 1988 on refusal to pay it. Under the section, such passengers can be sent to prison for up to one month or fined Rs 200 or both.

### CBI arrests 3 in bribery case, 2 are PESO Nagpur officials

The Central Bureau of Investigation (CBI) on Thursday arrested four persons, including two deputy chief controllers of Petroleum and Explosives Safety Organisation (PESO) in Nagpur, a di-

rector of a private company based at jasthan, and a tout, in an alleged bribery case

According to the agency, one Priyadarshan Deshpande acted as middleman between Devi Singh Kachhawaha, the director of M/s Shivshakti Chemical Pvt Ltd Devi, and the officials of PESO, Vivek Kumar and Ashok Dalela for a contract. Officials said the PESO officials were paid Rs10 lakh by Kachhawaha.
