Sub: Imposition of fine by Regulatory Body

Ref: Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015.

Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements)

Regulations, 2015, we hereby inform the details of the fine imposed on Venus Remedies Limited by BSE and NSE for omission to submit a single page containing standalone profit and loss statement for the period ended on 30th September 2023.

In this regard we want to clarify that this incident happened due to an inadvertent scanning error, a single page containing the statement of profit and loss account was unintentionally omitted during the scanning process.

Further this is to mention that the complete financial results, including the statement of profit and loss account, were duly submitted to the exchange within the prescribed time frame in XBRL format. Additionally, financial results were published in newspapers and the same was disclosed to the stock exchanges within the stipulated time frame.
