IIM defends ₹2-cr variable pay citing his 'performance'

MONTHS AFTER THE Union Government amended the Indian Institute of Management (IIM) Act, granting it greater say in the functioning of the 20 premier business schools, the Education Ministry has launched an inquiry into the accounts of IIM-Rohtak to investigate allegations of financial irregularities, including a complaint that the institute "illegally" transferred Rs 2 crore to its director's account as "vari-

able pay." The Indian Express has learned that the ministry, a little less than two months ago, tasked its Principal Chief Controller of Accounts with investigating allegations of funds embezzlement by the institute's director, Dheeraj Sharma, in the form of "variable pay" and charging of "exorbitant fees from students," among other concerns. scrutiny for allegedly misrepresenting his educational qualifications to secure his initial term as IIM Rohtak's director in 2017. The job required a first-class Bachelor's degree, but he had obtained a second division at the undergraduate level.

The government acknowledged this discrepancy in the Punjab and Haryana High Court in March 2022, only after he completed his first term. Despite objections from the ministry representative on the institute's Board of Governors (BoG) due to revelations about his academic credentials, Sharma was reappointed for a second term by the Board as the institute's head in February 2022.

According to the latest complaint that the Ministry has taken cognizance of, the institute is accused of transferring Rs 2 crore to Sharma's account as "variable pay" for the years 2018-19 and 2019-20 without approval of the Board. The Indian Express has learned that the institute has

defended this money transfer on the ground that it was approved by the BOG in its 45th meeting held on December 11, 2020 on account of meeting "performance parameters.

Apart from this, the

inquiry will look into at least 10 complaints that the government has received from students on the institute refusing to refund their fee deposit despite withdrawal of their admission from its fiveyear integrated programme in management and PhD programmes. It will also probe whether the institute charged "exorbitant fee" from students despite having adequate reserves and thereby defeating the "not-for-profit motive" of education laid

down by law. The inquiry comes months after the Education Ministry, in a surprising move, introduced an amendment Bill for the IIM Act during the monsoon session last year in July, significantly diluting the autonomy granted to the 20 IIMs five years ago with the enactment of the IIM Act in 2018.

The changes were made to entrust the management accountability of the IIMs with the President, who will be the Visitor to the premier Bschools with powers to audit their functioning and remove or appoint directors.

Earlier, these powers were vested in the IIM Board with the Union government having little say in the matter.

A week after its team was attacked, ED back in action in West Bengal

SEVEN DAYS AFTER an Enforcement Directorate team was assaulted in West Bengal's Sandeshkhali area when they went to conduct searches at the premises of a Trinamool Congress leader, the agency was back in action on Friday — albeit with far more backup. The ED raided the resi-

dences and offices of West Bengal minister Sujit Bose, TMC MLA Tapas Roy, and former chairman of the North Dum Dum municipality Subodh Chakraborty in connection with a municipal recruitment scam. This time, central forces accompanying the ED officials were seen donning helmets and body shields, and carrying teargas canisters. This is apart from their usual gear of batons and arms.

Near Bose's residence in Sreebhumi, central forces – including women personnel – conducted an area domination exercise once ED officers were inside the house. They could be seen patrolling the street in front of the residence every hour, dispersing the crowd before it could swell.

On January 5, when an ED team went to conduct searches at the home of TMC leader Sheikh Shahjahan in North 24 Parganas district, in connection with an alleged ration scam case, they were attacked by a mob of hundreds, who also manhandled accompanying CRPF personnel. Three ED officers had sus-

tained serious injuries. The extra precaution on Friday appeared to be in response to that attack. "Kuch hai kya? Kuch dikhana chah rahe ho yahan khade ho kar? Yahan se hato (Are you trying to prove something by stand-

ing here? Get away from here)," central force personnel could be seen tersely telling youths near Bose's home.

Personnel of the West Bengal police were also seen in areas that were raided.

Friday's raids started at 6.30 am and focused on Bose's two residences on the fringes of Kolkata; Roy's apartment and office in Kolkata's Bowbazar; and Chakraborty's residence in

Birati, North 24 Parganas. It is alleged that hundreds of jobs – in Group C, Group D and other positions in municipalities – were given

in exchange for money. Roy, the TMC deputy chief whip in the Assembly, is an MLA from Baranagar, which is one of the municipalities under the ED's radar. Bose's residence was raided in connection with alleged recruitment scams in North and South Dumdum municipalities.

"Seventy TMC leaders are involved in the recruitment scam. They should all start packing their bags and I advise them to take some warm clothes," said Suvendu Adhikari, BJP MLA and leader of the Opposition in the state Assembly.

TMC's Sashi Panja, the state Minister for Women and Child Development, said, "People of Bengal know that it is only a political vendetta by the Centre and the party ruling at the Centre."

Kunal Ghosh, the TMC secretary spokesperson, said, "Once again the ED is conducting raids here. This is happening through a script prepared by the BJP. The BJP cannot fight us politically. That is why they have given a list of our leaders to central agencies and asked them to harass the leaders."


