3]	The Company was engaged in trading of steel products. Accordingly, this is the only business segment and hence, reporting requirements
	of Segment Reporting as per Ind AS 108 "Operating Segments" are not applicable to the Company.
	During the earlier years, the Company had given Inter Corporate Loan to Williamson Financial Services Limited ("the recipient Company") amounting to Rs 485 lakhs. Considering the financial position of the recipient Company, the management had decided not to recognise interest income on the same. During the financial year ended 31st March, 2023, without prejudice to any of the legal rights and remedies available to recover the outstanding amount, the Management had recognised a full provision against the outstanding amount. During the quarter ended 31st December, 2023 the Company has recovered Rs. 15 Lakhs against the same.
	The Company has unabsorbed depreciation and carry forward losses under Income Tax Laws on which it has not recognised deferred tax asset, since it may not have sufficient future taxable income against which the deferred tax asset can be realised.
