However, due to a typographical error, the quorum was inadvertently typed as 2 instead of 4 in the Corporate Governance Report for the quarter ended December 31, 2023. Further, we have also filed the revised Corporate Governance Report for said Quarter on the BSE portal. Accordingly, the Company has filed an application for waiver of the fine imposed on 22.02.2024 and the response on the same is awaited. Since the response on waiver application is pending, the Company has deposited fine of Rs. 10,000/- plus applicable GST on 6th March 2024 in accordance with the SOP-C Review/Dec23-Q/22-02-2024.
