Tech CEOs call for Netanyahu's exit

Several business leaders have harshly criticised their prime minister for refusing to accept responsibility

Negating the notion of "you do not switch (leadership) during war", several leading Israeli tech company leaders have called for Prime Minister Benjamin Netanyahu's ouster as soon as possible to "cut down losses".

Israel's longest-serving prime minister who has been at the helm of affairs since 2009 except for a brief 13-month gap, has desisted from taking any blame for it. More than 1,400 Israelis were killed and around 200 were taken hostage when Hamas carried out a dastardly attack infiltrating several communities in the south of Israel.

The Israeli Prime Minister later removed the tweet on social media platform X following sharp reactions from leaders within his coalition and opposition alike with a rare apology. "As CEO, the responsibility is always on me, I can't blame managers below me.
