The MCA has further clarified vide it's circular no. 09/2023 dated 25th September 2023 that for companies that are required to provide e-voting facility under the Act, while they are transacting any business (es) only by postal ballot up to September 30, 2024, the requirements provided in Rule 20 of the Companies (Management and Administration) Rules, 2014 (the "Rules") as well as the framework provided in the MCA Circulars is applicable mutatis mutandis.

The Company has accordingly sent Postal Ballot Notice by email to all its shareholders for passing 1 (One) Ordinary Resolution for the special business as mentioned in the notice of postal ballot dated February 01, 2024 who have registered their email addresses with the Company or depository/ depository participants/ Registrar and Share Transfer Agent (RTA) as on February 01, 2024 and the communication of assent / dissent of the members are taken place through the remote e-voting system.
