Pursuant to Regulation 30 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("LODR Regulations"), this is to inform you that the Company has received an intimation under Section 143(1) of the Income Tax Act, 1961 from Centralized Processing Center, Income Tax Department bearing an Income Tax demand Rs. 10,46,49,620/- (Ten crores forty-six lacs forty-nine thousand six hundred twenty only) for the Assessment Year 2023-24.

The Income Tax demand arose on account of non-grant of credit of self-assessment tax paid aggregating to INR 10 crore, but incidentally wrong challan no & BSR code stated in ITR and consequentially, interest has been levied under sections 234B and 234C of the Act, resulting into the aggregate demand of Rs. 10,46,49,620/-.

Based on our assessment, we believe that the Demand Notice does not have any material impact on the financials, operations, or other activities of the Company
