

**Notes to the Financial Results:**

- 1 The above Unaudited Financial Results have been reviewed and recommended by the Audit Committee and taken on record & approved by the Board of Directors in their respective meetings held on 11th November, 2019.
- 2 Limited Review of the Unaudited Financial Results for the quarter and half year ended on 30th September, 2019 has been carried out by the Statutory Auditors.
- 3 During the previous financial year, the process of voluntary liquidation of GIPCL Projects & Consultancy Company Limited (GIPCO), a wholly owned subsidiary, was initiated and the affairs of GIPCO were handed over to the Liquidator. The winding up of GIPCO by the Liquidator commenced on 3rd January 2019, the date of appointment of the Liquidator and was closed on 20th March 2019 as per the final report submitted by the Liquidator. The Company had received Rs. 37.50 Lakhs as full and final liquidation distribution proceeds against its investment of Rs. 25.00 Lakhs and the subsidiary has no assets or liability from the previous year end.  
Given the completion of liquidation process and report submitted by the Liquidator as stated above in addition to the subsidiary having no assets, liabilities or outstanding members balances as at 30th September 2019, no consolidated financial results are presented by the Company.
- 4 Effective 1st April 2019, the Company has adopted Indian Accounting Standard (Ind AS) 116 "Leases". The Standard primarily requires the Company, as a lessee to recognize, at the commencement of the lease a right-of-use (ROU) asset and a lease liability (representing the present value of unpaid lease payments). Such ROU assets are subsequently depreciated and the lease liability reduced when paid, with the interest on the lease liability recognized as finance costs. The Company has elected to use the "Modified retrospective approach", i.e., where the cumulative impact, if any, recognized on the date of initial application of Ind AS 116 has resulted in net increase in ROU asset of Rs. 13,238.06 Lakhs and a corresponding lease liability (net of prepayments) of Rs. 378.88 Lakhs as at 30th September 2019. Further, there is no impact on the retained earnings as at 1st April 2019 and there is no material impact on financial results for the quarter and half year ended on 30th September, 2019.
- 5 The Company has only one reportable business segment namely "Power Generation".
- 6 Figures of the previous period have been re-grouped /re-arranged wherever necessary.

1.
