The E-Voting process was conducted for the below mentioned resolutions, as per Section 108 of the Companies Act, 2013 between 3rd September, 2019 (9:00 a.m.) to 5th September, 2019 (5:00 p.m.).

The equity shareholders of the Company as on the "cut-off" date i.e. Friday, August 30, 2019 were entitled to vote on the resolution nos. 1 to 5 as set out in the Notice.
