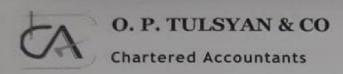

### Notes to Standalone Financial Results:

- 1. The above results for the quarter ended June 30, 2021 have been reviewed and recommended by the Audit Committee and approved by the Board of Directors at the respective meetings held on 10.08.2021.
- 2. The Financial Results have been reviewed by the Auditors appointed for this purpose as required under regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements).
- 3. The Company operates only in one business segment i.e. Retail Business of Consumer Electronics and home appliances. As such reporting is done on a single segment basis.
- 4. In this reporting quarter, operations and sales of the Company were adversely affected as showrooms of the Company were open only for 36 days with various restrictions including truncated timings due to lockdown/curfew imposed by the Government of Bihar in entire state to prevent and control the 2<sup>nd</sup> wave of Covid-19 pandemic. However, Company did exceedingly well on omni channel/on-line model of sale of products through its own on-line shopping portal/App platform. Unfortunately, this situation continued even in the current quarter as showrooms were operational only 3 days of the week with restrictions till 6<sup>th</sup> August including truncated timings.
- 5. The financial result of the company is also available on stock exchange website www.bseindia.com and on the company website www.adityavision.in.
