within the meaning of Section 2(45) of the Companies Act, 2013, the power to appoint functional/ Official Part-time non-Official Part-time Directors Directors (Independent Directors) vests with the Government of India.

Accordingly, the listed entity requested NSE & BSE for waiver of the penalty as the power to appoint Independent Directors on the Board of Directors of POWERGRID vests with Government of India.

The aforesaid non-compliance for the 2<sup>nd</sup>; 3<sup>rd</sup> and 4<sup>th</sup> Quarter (FY 2018-19) was also placed before the Board in its held 03.01.2019; meetings on 16.02.2019 and 07.05.2019, respectively, as per SEBI circular dt. 03.05.2018. The Board observed that the power to appoint Independent Directors vests with the Government of India. The Board directed that the matter regarding filling up of vacant posts of Independent Directors be pursued with the Administrative Ministry. The aforesaid direction of the Board was also informed to NSE and BSE
