Maha ex-home minister Deshmukh's premises in Nagpur, Mumbai raided

THE ENFORCEMENT DIRECTORATE (ED) on Friday conducted searches on the premises of former Maharashtra home minister Anil Deshmukh in Nagpur and Mumbai as part of a money laundering probe against him, officials said.

It was not known if Deshmukh, 71, was present. The central agency had registered a criminal case under the anti-money laundering law against Deshmukh and others last month after studying a CBI FIR.

The ED case came about after the CBI first carried out a preliminary enquiry followed by a regular case filed on the orders of the Bombay High Court, which asked it to look into the allegations of bribery made against Deshmukh by former Mumbai Police commissioner Parash Ram Singh.

Create petroleum-like reserve of oxygen: NTF to SC
