This is in reference to the clarification announcement issued by BSE for seeking clarifications from the Company in relation to the significant movement in price of the security of the Company, in order to ensure that investors have latest relevant information about the company and to inform the market so that the interest of the investors is safeguarded. We aren't able to access emails on office domain since the place of work is closed due to outbreak of COVID-19 and this "Clarification cum Announcement" is being made pursuant to the message seeking clarification displayed on the "Corporate Announcement" section on BSE Website.

At the outset, we would like to submit that the Company has no knowledge of the rationale behind the significant movement in price. We would like to clarify that we have no information of the company that is likely to change the perceived value of a security when it is disclosed to the public.

We hereby submit that we have no non-public facts that can provide a financial advantage in the market leading to this movement in price in any manner whatsoever requiring disclosure or soliciting clarification or dissemination from the Company. All the material information, that have bearing on the operation/performance of the Company which include all price sensitive information under Regulation 30 of SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, have always been disclosed by the Company within the stipulated time. Further, the Company has always provided timely clarification/ information sought by the Stock Exchanges(s). There is no pending information or announcement from the Company which may have a bearing on the price movement of the securities issued by the Company.
