# From the Desk of the Managing Director

Dear Partners,

I would like to take this opportunity to address you and provide an overall performance of the Company over the past year.

The FY23 fiscal came hard on the heels of an exceptional preceding financial year. While FY22 was a stupendous year for listed companies across India, including us, its exuberance did not endure through FY23. The first half showed some buoyancy despite tremendous volatility in crude and associated raw material prices. An extended monsoon and a shortened festival season precipitated in significant headwinds in the third quarter. Vulnerable to these, our customers experienced affected volumes and profitability. Our revenue for the year was at Rs 558.67 crores reflecting around 5% decrease compared to the previous year. Our profitability reduced mainly due to lower tonnage by 3% coupled with reduction in sales price by 2% due to fall in polymer prices.

We have already initiated strategic measures to navigate these challenges and position ourselves for sustainable growth. We have reached out to newer markets in food and beverage like dairy and ice-creams, construction chemicals and personal care to diversify our product portfolio and explore new market areas. We have increased our focus on Research and Development to explore and introduce innovative packaging solutions that minimise environmental impact.

Looking forward, we are focusing on three areas.

Firstly, we are strengthening our **sustainability goals**. Trials have been underway across all our facilities to use lesser raw material to manufacture products that test same or better on the given performance parameters. We have further challenged ourselves to use greater quantities of not only recycled polymers but also natural materials, again without compromising on quality. We are determined to reduce our carbon footprint by way of modernizing our fleet of machines that will be powered by solar electricity. We are also identifying methods to curtail the use of wasteful packaging material by largely reusing the polybags, sacks and cling films. These are arduous goals, but we are steadfast in our perseverance to meet decarbonization objectives laid out for the next few years.

Secondly, we are reinforcing our **customer engagement**. Our customer centricity continues to drive our innovations almanac. With the country's population skewed largely towards a younger, rapidly urbanizing population with growing disposable income, the food & beverage and consumer goods industries are nearing imminence of greater proportions. These are followed closely by agricultural chemicals. Evolving preferences will lead to globalized supply chains and therefor greater focus on retail and bulk packaging with enabling technologies. We are very optimistic on these growth industries and are determined to partner with them from the ground up.

Thirdly, we continue to improve our standards of **operational excellence**. We have always cultivated a culture around six sigma. It has led to not only improvements in cost optimization but also greater quality outputs. We continue to concentrate on lowering our internal rejections and obtaining Green Channel certifications across all our manufacturing plants. For new developments, we are aligning our Department of Scientific and Industrial Research certified Centre of Excellence to produce various moulds that are right first time. We have planned machine modernisation and mould manufacturing capability enhancement in our strategic initiatives which will propel our growth to meet increasing requirements of customers.

Our CSR efforts continue to dynamically drive our efforts to democratise yoga training. Our resolution to train children at orphanages yielded remarkable results this year. It was evident in their exemplary performances at the celebration of the 8th Annual International Day of Yoga in June 2022. The event itself was a grand celebration graced by our Honourable Prime Minister Shri Narendra Modi in Mysuru. Needless to say, we feel proud as well as honoured to have been a part of this momentous event.

I express my sincere gratitude to all stakeholders for their continued trust and unwavering support during these challenging times and wish that you continue to partner with us in our journey to meet our ambitions for the future.

I am confident that our strategic initiatives and commitment to sustainability will position the Company as a leader in the evolving packaging industry.

In compliance with the provisions of Section 108 of the Act read with Rule 20 of the Companies (Management and Administration) Rules, 2014 and Regulation 44 of the Listing Regulations, (including any statutory modification(s) and/or re-enactment(s) thereof for the time being in force), the Company is providing facility of remote e-Voting to its Members in respect of the businesses to be transacted at the AGM. For this purpose, the Company has entered into an agreement with NSDL for facilitating voting through electronic means, as the authorized agency. - c. 29. SEBI vide its Circular No. SEBI/HO/MIRSD/MIRSDPoD-1/P/CIR/2023/37 dated March 16, 2023, in supersession of earlier Circular(s) issued on the subject, has prescribed common and simplified norms for processing investor's service request by RTAs and norms for furnishing PAN, KYC (contact details, bank details and specimen signature), and nomination details.

As per the said Circular, it is mandatory for the shareholders holding securities in physical form to, inter alia, furnish PAN, KYC, and nomination details. Physical folios wherein the PAN, KYC, and nomination details were not available on or after April 01, 2023, were to be frozen by the RTA and would be eligible for lodging grievance or any service request only after registering the required details. The said timeline of April 01, 2023 for freezing of folios has been extended to October 01, 2023.

Any payments including dividend in respect of such frozen folios shall only be made electronically with effect from April 01, 2024, upon registering the required details. The said physical folios shall be referred by the Company or RTA to the administering

The Securities and Exchange Board of India (SEBI) vide its circular dated May 09, 2018 has amended SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 and has now mandated all listed companies vide Regulation 17(1A) of SEBI (Listing Obligations

and Disclosure Requirements) (Amendment) Regulations, 2018 to obtain shareholders' approval vide Special Resolution for appointment/continuation of directorship of any Non-Executive Director who has attained the age of 75 years w.e.f. April 01, 2019.

Since, Mr. Ashwin S. Dani, Non-Executive Director of the Company has attained the age of 80 (eighty) years, consent of the Members by way of Special Resolution is sought by the Company in compliance with Regulation 17 (1A) of SEBI (Listing Obligations and Disclosure Requirements) (Amendment) Regulations, 2018, for continuance of Mr. Dani's Directorship as Non-Executive Director of the Company beyond the age of 75 years.

The Shareholders based on the recommendation of Nomination & Remuneration Committee had earlier approved the continuation of directorship of Mr. Ashwin S. Dani beyond 75 years of age by passing a Special Resolution at the Annual General Meeting of the Company held on July 29, 2021 and also vide postal ballot on December 22, 2018.

Mr. Ashwin S. Dani is the founder Promoter & Non-Executive Chairman of the Company and has vast and rich experience in the field of paints and packaging industry. His knowledge of the industry and business environment has been an asset to the Company. The Company is driven by his vision and under his esteemed guidance the Company has attained a remarkable growth in packaging industry.

Relevant details relating to continuation of Directorship of Mr. Ashwin S. Dani, including his profile, as required by the Act, Listing Regulations and Secretarial Standards issued by ICSI are provided in the "Annexure" to the Notice.

Mr. Ashwin S. Dani is not disqualified from being appointed as a Director in terms of Section 164 of the Act and has consented to act as Director of the Company.

Based on the recommendation of Nomination & Remuneration Committee the Board of Directors recommends passing of the Special Resolution as set out at Item No. 4 of this Notice for continuation of Directorship of Mr. Ashwin S. Dani beyond the age of seventy-five years.

None of the Directors or Key Managerial Personnel of the Company or their relatives except Mr. Ashwin S. ### OVERVIEW OF FINANCIAL PERFORMANCE

During the financial year 2022-23,

- Operating revenue was ₹ **55,867.42** lakhs as against ₹ 58,845.52 lakhs in the previous year, a 5% decrease.
- EBIDT is ₹ **7,592.58** lakhs as against ₹ 8,659.16 lakhs in the previous year, a decrease by 12.3%.
- Exceptional Item (charge)/credit includes Profit of ₹ 380.61 lakhs on compulsory acquisition of property at Naroli (vacant land) by the Gujarat government for bullet train project (Previous year figures represent sale of balance property at Naroli which was vacant land). The profit on sale of property being a non-recurring event has been considered as an exceptional item.

- Net Profit after tax was ₹ **2,832.92** lakhs as against ₹ 3,739.66 lakhs in the previous year a reduction of approximately 24%.
- The company has evaluated the option of lower tax rate allowed under Section 115BAA of the Income Tax Act, 1961 as introduced by the Taxation Laws (Amendment) Ordinance, 2019, choosing to exercise the option of lower tax rate of 25.17% (inclusive of surcharge and cess) since MAT credit is now fully utilized.

### SALE OF IMMOVABLE PROPERTY

Vacant land admeasuring 4020 square meters situated at T VILLAGE Naroli Union territory of Dadra and Nagar Haveli and Daman & Diu which was lying idle and unemployed with the company was acquired by the Government for bullet train project for a consideration of ₹ 485.98 lakhs and the same has been received by the Company as on the date of this report.

### DIVIDEND

The Board of Directors at its meeting held on May 17, 2023 have recommended payment of dividend of ₹1/- (Rupee One only) per Equity Share of ₹ 10/- each for the financial year ended March 31, 2023, the same amounts to ₹ 171.76 lakhs. The above is subject to the approval by the shareholders at the ensuing Annual General Meeting of the Company and hence is not recognised as a liability.

### TRANSFER TO RESERVES

During the year under review, no amount has been transferred to General Reserve.

## ANNEXURE C TO BOARD'S REPORT

Details of Conservation of Energy, Technology Absorption, Foreign Exchange Earnings and Outgo are as follows:

### A) CONSERVATION OF ENERGY:

#### a) The steps taken for conservation of energy:

We continue to make efforts for conservation of energy in Company's day to day operations. At all manufacturing facilities, our primary focus is on improving efficiency at all levels with an emphasis on energy conservation. We examine the machinery requirement with respect to articles to be produced and optimized selection for the least energy consumption options with precision in output. All these efforts resulted in energy saving by 14% and Productivity increase by 12% on average. Our proximity to customer locations also contributes to reducing the energy footprints in transportation.

During the year under review the Company has focused more on:

- optimized selections of machinery and equipment for least energy consumption.
- improving technology for energy conservation.
- improving efficiency of production with a view to conserving energy.
- Energy Audit at our major plants.

#### b) Specific Energy Conservation measures taken during the year are:

- Installation of new Servo & All electric Injection Moulding Machines to save energy.
- Control on energy inputs to machines.
- Exploring replacement of hydro motors with servo motors.
- Monitoring and analysis of energy consumption on daily basis. All new Injection machines installed with auto Energy monitoring.
- Replacement of old conventional moulding machines with new ones, which are always either servo controlled or hybrid or fully electric.
- Constant monitoring of machines to optimize productivity.
- Installation of solar panels at various plants to service our electricity needs.

#### c) Steps taken by the Company for utilizing alternate sources of energy:

Your Company has invested in windmill energy and started to invest in solar power in suitable areas of operations. These measures are likely to result into reduction in usage of conventional energy sources / saving in energy cost and environmental benefits in the vicinity.

##### Windmill

Installation of Windmills in some of its plants as an alternative source of energy will facilitate the reduction in conventional energy usage and environmental benefits.

##### Solar energy

Your Company has started installing solar cells at various plants to supplement requirements of power and is working towards extending to the new manufacturing facilities as well. Project at Naroli plant to install 350 KW solar power project was partly completed upto 175 KW and balance to be completed in the coming financial year. Evaluation for rollover of Solar power system at other plants like Rohtak, Khandala, Mysuru, Sriperumbudur and Vizag is being done which is expected to generate approximately 4 MW of additional solar power.

#### d) The Capital Investment on Energy Conservation equipment during the year:

The Company has entered into an agreement for installation of an Energy Conservation equipment at Company's Naroli Plant wherein 175 KW is installed and for balance 100 KW, the project is completed in May 23. We are in the process of evaluating the offer for Offsite Solar energy contract sign off for 15 Years for our Mysuru Plant and for roof top Solar projects for our other key plants is at finalization and approval stage.

### B) TECHNOLOGY ABSORPTION

Your Company has a dedicated Technology Centre at Pune (Sanaswadi) that carries out design, product and process innovations and improvements. It has also received accreditation from the Department of Scientific and Industrial Research (DSIR), New Delhi. New product design as per customer requirement, RPT development with selection of correct grade of polymer, supporting sustainability initiatives within the company and a reduction in production cycle time leading to savings in operating costs, are some of the initiatives by the Technology Centre. Upgradation in technology and reduction in production cycle time will help sustaining and strengthening the competitive position of the Company and facilitate customer satisfaction.

#### a) The efforts made by the Company towards technology absorption

- Technology upgradation: Efforts are taken to go for all electric machines where no oil is permitted in the moulding environment and cycle time is below 12 seconds and above which shall be justified with all Electric/ Servo with Hybrid technology/ or Complete Servo Machine. Two platen machines are also of Servo hydraulic which will help reduce cycle time.
- Efficient conversion by selection of customized blow molding machine specifications to ensure higher customer satisfaction.
- Technology upgradation through Identify correct EBM Multilayer Machines to meet Sustainable /PCR Grade material use in middle layer.
- Selection of Multilayer EBM (more than 3 Layer) for Food and Beverages and Pharma Application is under process for new business requirement.
- Automation: Extrusion Blow Molding (EBM) process is currently based on lot of manual processes. We are under process to implement semi automation in this process and reduce manual intervention. The high-volume products are identified to be converted from manual to fully automatic process using latest cutting edge technology EBM Machines.

- Labour reduction: New cutting-edge Technology EBM Machines shall reduce manual activity to bare minimal. Analysis is on to convert High volume bottles from EBM to IBM as much as possible to eliminate manpower for rework. Similarly, installation of ROBO on major Injection machine will help reduce manpower.
- b) Specific areas in which R & D was carried out by the Company includes:**
- Technology upgradation in product and mould design.
  - New Product designs for Caps and Closure and EBM & ISBM products.
  - Product design proposals to major OEMS for products other than pails.
  - Cooling efficiency: Identify New cooling systems like use of mould standard cooling accessories are being implemented in Caps and Closure.
  - Cycle time reduction in moulding through inhouse mould design for majority of our business other than pails.
  - Product and process development: Complete development cycle is in house.
- c) The Benefits derived like product improvement, cost reduction, product development or import substitution:**
- Introduction of Value type gate on all Food and aesthetic products.

- Enhanced competitiveness due to cost reduction and product development.
- Lower production cycle time improved productivity.
- Less molding rejections.

# MANAGEMENT DISCUSSION AND ANALYSIS

## OVERVIEW OF THE COMPANY

Hitech Corporation is a leading manufacturer of rigid plastic packaging solutions for a variety of customer segments across multiple geographies. These include customers from industries such as paints and coatings, agrochemicals, personal care, home care, pharmaceuticals, food & beverage and oils & lubricants. While it operates in a highly competitive space, its emphasis on sustainability, quality and innovation remains unwavering. Hitech serves marquee customers and industry leaders in each industry segment above.

With expertise in injection moulding, blow moulding, extrusion, the Company offers varied products at large-scale production volumes, with the ability to scale up to meet additional requirements at any of its 12 manufacturing locations across India.

The in-house Design and Development Centre provides innovative solutions and hand holds the customer from design to delivery of the product. Hitech is committed to maintain highest quality standards in its manufacturing processes which involves rigorous inspections and testing, getting it "Right First Time" and resulting in delivery of zero defect products to customers.

## GLOBAL ECONOMY

The global GDP in FY 2023 was affected by geopolitical uncertainty caused by the prolonged Russia-Ukraine war and resultant dislocations in supply chains, leading to production disruptions and higher costs for businesses in various sectors. As a result, the global GDP is estimated to have grown at a more subdued 3.4% in 2022, versus 5.9% in the prior year. Analysts estimate that in the coming year, the slowdown in economic growth will continue, however there might be a recovery in the second half of 2023 with lowering of inflation rates.

## INDIAN ECONOMY

India, despite of significant challenges in the global environment, was one of the fastest growing economies in the world. India's domestic growth prospects remain robust. The Indian economy expanded at 7.2 percent in FY 2023, with capital expenditure being a robust driver on the back of government infra push and private capex cycle. However due to increased inflation in the Indian economy with increase in crude oil prices, interest rate hikes were done by the Reserve Bank of India to control inflation. The weakening of the Indian Rupee against the US dollar also added to the inflationary pressures.

The GDP growth forecast of India for FY 2024 is 6.5 percent with inflation being under control, strong domestic demand and healthy consumption growth. Crude oil which drives the polymer prices is also expected to be range bound without any major shocks on the supply front.

## BUSINESS SEGMENTS

Hitech has a robust business model serving the packaging needs of some of the most promising sectors of the Indian economy. Given below is the outlook for the industries it serves.

### Paint Industry

The Indian Paint Industry is today worth over ₹ 62,000 crores. Both the decorative and industrial paints and coatings segments are projected to grow at a healthy CAGR for the next few years, on the back of rising discretionary incomes, trend of nuclear families and house constructions, increased frequency of redecorating the houses, increase in manufacturing activity and usage of construction chemicals such as waterproofing.

### FMCG

FMCG market in India is projected to grow at a CAGR of 14.9% to USD 220 billion in the next couple of years with the packaged food market growth upto USD 70 billion. This is composed of several consumption driven segments such as foods and beverages, personal care, home care, fabric care and so on. In each segment, a young population with rising participation of women in the workforce and demographic changes have led to an increased use of packaged foods/beverages and consumption of detergents/soaps/shampoos/fragrances and so on. This is a secular and structural growth trend where needs for sustainable and attractive packaging solutions play a big role in a brand's marketing strategy and hence a high involvement decision from the brand point of view. The scope to offer aesthetically, technologically advanced and sustainable packaging solutions is immense in this segment. Hitech's operational stature will allow it to meet the industry's rising packaging standards and needs.

### Agro Chemical

The India agrochemicals market is driven by the rising population within the country, which has led to maintaining sufficiency in agricultural practices, further boosting the use of Indian agrochemical products for farming activities. Packaging plays a crucial role in the agriculture industry, as agrochemical products such as fertilizers and pesticides are toxic. Hence, they need advanced packaging solutions, which can reduce the risk of handling, storing, and transporting these chemical products. High demand for the pest resistance across the globe and the advancement of biodegradable packaging solutions is fuelling the growth of packaging market of agro chemicals. Recycling and environmental concerns are vital challenges for this market. Hitech is set up to be not only enterprising but also dexterous to resolve the packaging challenges that will come with this expansion.

### **Lubricants**

The India Industrial Lubricants Market is segmented by Product Type (Engine Oil, Transmission and Hydraulic Fluid, Metalworking Fluid, etc.) and End-user Industry (Power Generation, Heavy Equipments etc). The global lubricant packaging market is estimated to reach US\$ 15.5 billion in 2029, exhibiting growth at CAGR of 5.2%. With the focus on clean environment, there are opportunities in this segment to address the Diesel Exhaust Fluid usage which is becoming commonplace with newer emission norms kicking in.

Hitech with its proven abilities, vast experience and customer centric focus is confident of increasing its market share in the Lubricant packaging market gradually.

### **CAPITAL EXPENDITURE & EXPANSION PLANS**

New projects using newer technologies with high volume demands are expected in the fiscal year 2024. The corporate thrust will be on three major areas:

- a. To improve our standards of **operational excellence**: Projects to improve efficiency at various manufacturing facilities are ongoing and will be completed as per plan. These include the systematic replacement of older machines with newer technology as well as the augmentation of existing machinery to support newer products and customer requirements. We will continue to concentrate on lowering our internal rejections and obtaining Green Channel certifications across all our manufacturing facilities.
- b. To strengthen our **sustainability goals**: We have challenged ourselves to use greater quantities of not only recycled polymers but also natural materials, without compromising on quality and durability of our products. We are determined to reduce our carbon footprint by modernizing our fleet of machines that will be powered by solar electricity.
- c. To reinforce **customer engagement**: With the rapidly urbanizing population having increased disposable income, the food & beverage and consumer goods industries are seeing good momentum. We have reached out to newer markets like dairy, ice-creams, construction chemicals and personal care to diversify our product portfolio and explore new market areas. We have increased our focus on Research and Development to explore and introduce innovative packaging solutions that minimise environmental impact. Evolving preferences will lead to globalized supply chains and therefore we will have greater focus on retail and bulk packaging with enabling technologies. We are very optimistic on these growth industries and are determined to partner with them from the initial stage.

### **OPPORTUNITIES, RISKS AND THREATS**

Our biggest strength is our Pan India presence by having 12 manufacturing facilities across the country. The biggest opportunity for us is to take a lead in sustainable packaging and we are working with experts from the industry and academia to offer the most cost-effective alternatives to our customers. Industry 4.0 provides a leap in manufacturing sector evolution, and Hitech will leverage this fully to modernize its fleet of machines and improve operational efficiency. Hitech continues to focus on offering innovative solutions to our customers for their unique needs which could be better transportation and handling conditions, preventing counterfeiting, attractive labelling and so on. We are also strengthening our Design & Development team by inducting necessary software tools to offer new solutions to our customers. We aspire to be the partner of choice for our customers' unique requirements. General economic slowdown, that impacts our customer segments, as well as fluctuating polymer prices pose the most direct risks to us.

### **HUMAN RESOURCES**

Every employee at Hitech is valued and respected for the myriad of contributions made. To nurture this environment of open exchange, each employee's wellbeing and continued knowledge and skill enhancement is our topmost priority. We have several on-going training programs at our manufacturing facilities and offices to enhance their learning and create an inclusive environment that values different perspectives, experiences and backgrounds.

### **ENVIRONMENT, HEALTH AND SAFETY**

Health and safety continues to be one of the most important values at Hitech. The Company has a comprehensive approach to ensure that all employees, assets and the environment are protected from harm. It has adopted a proactive approach to health and safety management, which includes creating policies and procedures to promote safe working practices and providing appropriate training to employees. The Company accords very high priority to safety in all aspects of its operations and conducts regular fire and safety audits at all its manufacturing facilities. The Company also ensures that it has the right systems in place at all times to monitor performance and identify potential safety risks thus mitigating any potential hazard.

## RESEARCH & DEVELOPMENT

Hitech's Design and Development Centre, accredited by the Department of Scientific and Industrial Research (DSIR) of the Government of India is at Sanaswadi. Mould design and development remains at the forefront of Hitech's technological enterprise, including other innovations ranging from low cost automation to process improvement complement its holistic approach towards providing customer delight. Our Design and Development Centre is working across several dimensions of creating better materials, using lesser materials without impacting the performance, using more sustainable alternatives and so on.

## INTERNAL CONTROL SYSTEMS

Hitech's internal control system is commensurate with the nature business, size and complexity of its operations and is aligned with the requirement of the Companies Act, 2013. 4. Power to borrow moneys, pursuant to Section 179(3)(d) of the Companies Act, 2013, to the extent of the limit as may be approved by the Board of Directors from time to time and to create the security for any such amount;
5. Power to make loans, pursuant to Sec 179(3)(f) of the Companies Act, 2013, to any employee of the Company utilising the funds of the Company, within an overall limit of Rs 30,00,000/- (Rupees Thirty Lakhs only) outstanding at any one time and that the loan given to any employee shall in no case exceed ₹ 5,00,000/- (Rupees Five Lakhs only). (The interest on such loans shall not be lower than the limits specified under Section 186(7) of the Companies Act, 2013.);
6. Power to enter into derivative transactions with Banks/ financial institutions to hedge the funding of External Commercial Borrowings (ECB) by Principal only swap (POS) and Coupon only swap (COS) and
7. Any other matters as may be delegated by the Board from time to time.

**7. INVESTMENT COMMITTEE**

The Board of Directors of the Company at its meeting held on February 11, 2023 has constituted an 'Investment Committee' consisting of all Independent Directors viz. Mr. Bomi P. Chinoy as Chairman and Mr. Harish N. Motiwala, Mr. Jayendra R. Shah & Ms. Kalapana V. Merchant as Members to oversee organization's strategic investments and whether they are managed in a way that aligns with the organization's goals and objectives.

As it is not a statutory committee, meetings are held as and when required and Minutes of the Meeting is placed before the ensuing Board Meeting. During the financial year no meeting of the said Committee was held.

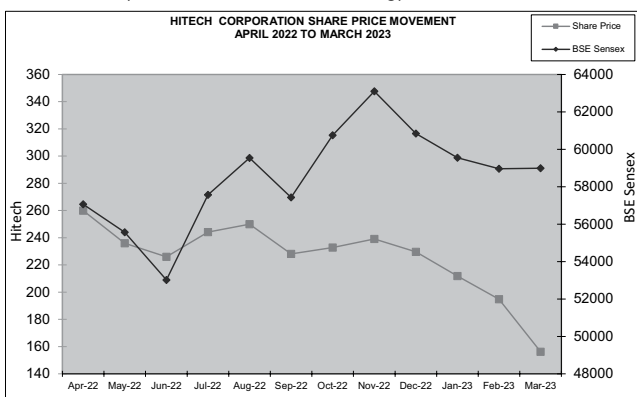

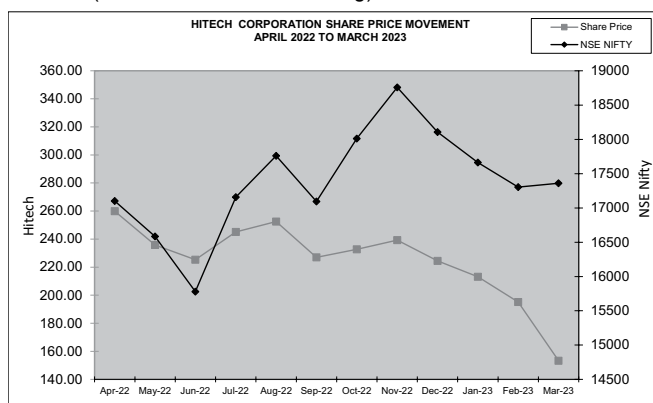

The chart below shows the comparison of your Company's share price movement on NSE vis-à-vis the movement of NSE Nifty for the year 2022-23 (based on month end closing).

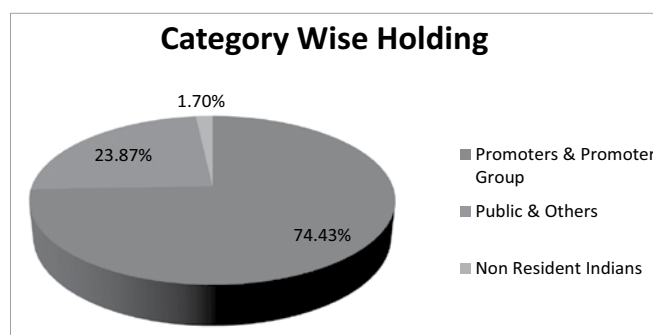

SEBI vide its Circular No. SEBI/HO/MIRSD/MIRSDPoD-1/P/ CIR/2023/37 dated March 16, 2023, in supersession of earlier Circular(s) issued on the subject, has prescribed common and simplified norms for processing investor's service request by RTAs and norms for furnishing PAN, KYC (contact details, bank details and specimen signature), and nomination details.

# Notes to the Financial Statements for the year ended March 31, 2023

## 1. CORPORATE INFORMATION

Hitech Corporation Limited ('the Company') is engaged in manufacturing of rigid plastic packaging products specially catering to customers relating to paints, lube, agro chemical, FMCG, personal and health care and home care product as well as export market.

The Company is a public limited Company domiciled in India and incorporated under the provisions of the Companies Act, 1956. Its shares are listed on two stock exchanges in India, namely the Bombay Stock Exchange Limited (BSE) and the National Stock Exchange of India Limited (NSE). The Company's registered office is at 201, Welspun House, 2<sup>nd</sup> floor, Kamala City, Lower Parel (W), Mumbai- 400 013. As at March 31, 2023, Geetanjali Trading & Investments Private Limited, the holding company owned 69.11% of the Company's equity share capital.

## 2. BASIS OF PREPARATION, MEASUREMENT, KEY ACCOUNTING ESTIMATES AND JUDGEMENTS AND SIGNIFICANT ACCOUNTING POLICIES

### 2.1. Basis of preparation

These financial statements of the Company are prepared in accordance with Indian Accounting Standards ('Ind AS') as notified by Ministry of Corporate Affairs pursuant to Section 133 of the Companies Act, 2013 ('Act') read with the Companies (Indian Accounting Standards) Rules, 2015 as amended.

These financial statements have been prepared and presented under the historical cost convention, on accrual basis of accounting except for certain financial assets and liabilities that are measured at fair values at the end of each reporting period, as stated in the accounting policies set out below. The accounting policies have been consistently applied except where a newly issued accounting standard is initially adopted or a revision to an existing accounting standard requires a change in accounting policy hitherto is in use.

#### Current versus non-current classification

All assets and liabilities have been classified as current or non-current as per the Company's normal operating cycle and other criteria set out in the Schedule III to the Companies Act, 2013. Based on the nature of products and the time taken between acquisition of assets for processing and their realization in cash and cash equivalent, the Company has ascertained its operating cycle as twelve months for the purpose of the classification of assets and liabilities into current and non-current.

### 2.2. Key estimates and judgements

In preparing these financial statements, management has made judgements, estimates and assumptions that affect the application of accounting policies and the reported amounts of assets, liabilities, income and expenses.

Uncertainty about these assumptions and estimates could result in outcomes that require a material adjustment to the carrying amount of assets or liabilities affected in future periods.

The areas involving critical estimates or judgements are:

- i. Determination of the estimated useful lives of property, plant & equipment and the assessment as to which components of the cost may be capitalized (Note 2.4 .1);
- ii. Determination of the estimated useful lives of intangible assets (Note 2.4 .2);
- iii. Recognition and measurement of defined benefit obligations, key actuarial assumptions (Note 38);
- iv. Recognition and measurement of provisions and contingencies, key assumptions about the likelihood and magnitude of an outflow of resources (Note 16);
- v. Fair value of financial instruments (Note 2.3);
- vi. Significant judgements are involved in determining the provision for income taxes, including amount expected to be paid/recovered for uncertain tax positions (Note 17);
- vii. The Company evaluates if an arrangement qualifies to be a lease as per the requirements of Ind AS 116. Identification of a lease requires significant judgment. The Company uses significant judgement in assessing the lease term (including anticipated renewals) and the applicable discount rate.

The Company determines the lease term as the non-cancellable period of a lease, together with both periods covered by an option to extend the lease if the Company is reasonably certain to exercise that option; and periods covered by an option to terminate the lease if the Company is reasonably certain not to exercise that option. In assessing whether the Company is reasonably certain to exercise an option to extend a lease, or not to exercise an option to terminate a lease, it considers all relevant facts and circumstances that create an economic incentive for the Company to exercise the option to extend the lease, or not to exercise the option to terminate the lease. The Company revises the lease term if there is a change in the non-cancellable period of a lease.

The discount rate is generally based on the incremental borrowing rate specific to the lease being evaluated or for a portfolio of leases with similar characteristics. This incremental borrowing rate reflects the rate of interest that the lessee would have to pay to borrow over a similar term, with a similar security, the funds necessary to obtain an asset of a similar nature and value to the right- of - use asset in a similar economic environment. Determination of the incremental borrowing rate requires estimation.

### 2.3. Measurement of Fair Value

The Company's accounting policies and disclosures require financial instruments to be measured at fair values.

The Company has an established control framework with respect to the measurement of fair values. The Company uses valuation techniques that are appropriate in the circumstances and for which sufficient data are available to measure fair value, maximizing the use of relevant observable inputs and minimizing the use of unobservable inputs.

The management regularly reviews significant unobservable inputs and valuation adjustments. If third party information, such as broker quotes or pricing services, is used to measure fair values, then the management assesses the evidence obtained from the third parties to support the conclusion that such valuations meet the requirements of Ind AS, including the level in the fair value hierarchy in which such valuations should be classified.

Fair values are categorised into different levels in a fair value hierarchy based on the inputs used in the valuation techniques as follows:

*Level 1:* quoted prices (unadjusted) in active markets for identical assets or liabilities.

*Level 2:* inputs other than quoted prices included in Level 1 that are observable for the asset or liability, either directly (i.e. as prices) or indirectly (i.e. derived from prices).

*Level 3:* inputs for the asset or liability that are not based on observable market data (unobservable inputs).

If the inputs used to measure the fair value of an asset or a liability fall into different levels of the fair value hierarchy, then the fair value measurement is categorised in its entirety in the same level of the fair value hierarchy as the lowest level input that is significant to the entire measurement.

The Company recognises transfers between levels of the fair value hierarchy at the end of the reporting period during which the change has occurred.

### 2.4. Significant Accounting Policies

#### 1. Property, Plant and Equipment

##### Recognition and Measurement

Items of property, plant and equipment, other than freehold land that qualifies as an asset is measured on initial recognition at cost. Following initial recognition, items of property, plant and equipment are carried at its cost less accumulated depreciation and accumulated impairment losses. Freehold land is carried at cost and is not depreciated.

The cost of an item of property, plant and equipment comprises of its purchase price including taxes (other than those subsequently recoverable from tax authorities), duties, freight and other directly attributable costs of bringing the asset to its working condition. Any trade discounts and rebates are deducted in arriving at the purchase price. Cost includes cost of replacing a part of plant and equipment if the recognition criteria are met. Expenses directly attributable to new manufacturing facility during its construction period are capitalized. Expenditure related to plans, designs and drawings of buildings or plant and machinery is capitalised under relevant heads of Property, Plant & Equipment if the recognition criteria are met.

Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. The carrying amount of any component accounted for as a separate asset is derecognised when replaced. All other repairs and maintenance are charged to the Statement of Profit and Loss during the reporting period in which they are incurred.

##### Depreciation

Depreciation on property, plant & equipment other than factory buildings is provided on the straight-line method, pro rata to the period of use, over their useful life. Depreciation on factory buildings is provided on written down value method, pro rata to the period of use, over their useful life. The estimated useful lives of assets are as follows:

(\*) Based on technical evaluation of useful life by the Management, it believes that the useful lives as given above best represent the period over which the Management expects to use these assets. Hence, the useful lives for these assets is different from the useful lives as prescribed under Part C of Schedule II of the Companies Act, 2013. The residual value of property, plant & equipment except factory buildings, is considered at ₹ Nil as the realisable value at the end of useful life is not expected to be significant. In case of factory building the residual value is estimated by management to be at 5% of cost.

The useful lives, residual values of each part of an item of property, plant and equipment and the depreciation methods are reviewed at the end of each financial year. If any of these expectations differ from previous estimates, such change is accounted for as a change in an accounting estimate.

## **Derecognition**

The carrying amount of an item of property, plant and equipment is derecognized on disposal or when no future economic benefits are expected from its use or disposal. The gain or loss arising from the derecognition of an item of property, plant and equipment is measured as the difference between the net disposal proceeds and the carrying amount of the item and is recognized in the Statement of Profit and Loss when the item is derecognized.

## **2. Intangible Assets**

### **Recognition and Measurement**

Intangible assets acquired separately are measured on initial recognition at cost. Following initial recognition, intangible assets are carried at cost less accumulated amortization and accumulated impairment loss, if any. Internally generated intangibles, excluding eligible development costs are not capitalized and the related expenditure is reflected in profit and loss in the period in which the expenditure is incurred.

### **Amortization**

Intangible assets with finite lives are amortised on a straight line basis over the estimated useful economic life. The amortization expense on intangible assets with finite lives is recognised in the Statement of Profit & Loss. The estimated useful lives for intangible assets are 3 years.

The amortization period and method for an intangible asset with finite useful life is reviewed at least at the end of each financial year. If any of these expectations differ from previous estimates, such change is accounted for as a change in an accounting estimate.

### **Derecognition**

The carrying amount of an intangible asset is derecognized on disposal or when no future economic benefits are expected from its use or disposal. The gain or loss arising from the derecognition of an intangible asset is measured as the difference between the net disposal proceeds and the carrying amount of the intangible asset and is recognized in the Statement of Profit and Loss when the asset is derecognized.

## **3. Right to use Asset**

The Company's lease asset classes primarily consist of leases for land, premises and vehicles. The Company assesses whether a contract contains a lease, at inception of a contract. A contract is, or contains, a lease if the contract conveys the right to control the use of an identified asset for a period of time in exchange for consideration. To assess whether a contract conveys the right to control the use of an identified asset, the Company assesses whether: (i) the contract involves the use of an identified asset (ii) the Company has substantially all of the economic benefits from use of the asset through the period of the lease and (iii) the Company has the right to direct the use of the asset.

At the date of commencement of the lease, the Company recognizes a right-of-use asset ("ROU") and a corresponding lease liability for all lease arrangements in which it is a lessee, except for leases with a term of twelve months or less (short-term leases) and low value leases. For these short-term and low value leases, the Company recognizes the lease payments as an operating expense on a straight-line basis over the term of the lease.

Certain lease arrangements include the options to extend or terminate the lease before the end of the lease term. ROU assets and lease liabilities include these options when it is reasonably certain that they will be exercised.

The right-of-use assets are initially recognized at cost, which comprises the initial amount of the lease liability adjusted for any lease payments made at or prior to the commencement date of the lease plus any initial direct costs less any lease incentives. They are subsequently measured at cost less accumulated depreciation and impairment losses.

Right-of-use assets are depreciated from the commencement date on a straight-line basis over the shorter of the lease term and useful life of the underlying asset. Right of use assets are evaluated for recoverability whenever events or changes in circumstances indicate that their carrying amounts may not be recoverable. For the purpose of impairment testing, the recoverable amount (i.e. the higher of the fair value less cost to sell and the value-in-use) is determined on an individual asset basis unless the asset does not generate cash flows that are largely independent of those from other assets. In such cases, the recoverable amount is determined for the Cash Generating Unit (CGU) to which the asset belongs.

The lease liability is initially measured at amortized cost at the present value of the future lease payments. The lease payments are discounted using the interest rate which is the incremental borrowing rates in the country of domicile of these leases. Lease liabilities are re-measured with a corresponding adjustment to the related right of use asset if the Company changes its assessment if whether it will exercise an extension or a termination option.

Lease liability and ROU asset have been separately presented in the Balance Sheet and lease payments have been classified as financing cash flows.

### **The Company as a lessor:**

Leases for which the Company is a lessor is classified as a finance or operating lease. Whenever the terms of the lease transfer substantially all the risks and rewards of ownership to the lessee, the contract is classified as a finance lease. All other leases are classified as operating leases.

When the Company is an intermediate lessor, it accounts for its interests in the head lease and the sublease separately. The sublease is classified as a finance lease or operating lease by reference to the right – of – use asset arising from the head lease.

For operating leases, rental income is recognized on a straight-line basis over the term of the relevant lease.

#### 4. Investment Property

##### Recognition and measurement

Investment properties are properties held to earn rentals and / or for capital appreciation. Investment properties are stated at cost less accumulated depreciation and accumulated impairment loss, if any. Freehold land is carried at cost and is not depreciated.

Cost includes purchase price, taxes and duties and other direct costs incurred for bringing the asset to the condition of its intended use. Subsequent costs are included in the asset's carrying amount or recognised as a separate asset, as appropriate, only when it is probable that future economic benefits associated with the item will flow to the Company and the cost of the item can be measured reliably. All other repair and maintenance costs are recognised in statement of profit and loss as incurred.

##### Depreciation

Depreciation on leasehold land is provided on a straight-line basis over the shorter of the lease term and useful life of the underlying asset.

Depreciation on building is provided on written down value method, pro rata to the period of use, over their useful life. The estimated useful lives based on technical evaluation by the Management is 40 years. The residual value is estimated by management to be at 5% of cost.

##### Derecognition

Investment properties are derecognised either when they have been disposed of or when they are permanently withdrawn from use and no future economic benefit is expected from their disposal. The difference between the net disposal proceeds and the carrying amount of the asset is recognised in the Statement of Profit and Loss in the period of derecognition.

#### 5. Non-current assets held for sale

Non-current assets held for sale are presented separately in the Balance Sheet when the following criteria are met:

- the Company is committed to selling the assets;
- the assets are available for sale immediately;
- an active plan of sale has commenced;
- sale is expected to be completed within 12 months; and
- it is highly probable that they will be recovered primarily through sales rather than through continuing use.

Assets held for sale are measured at the lower of their carrying amount and fair value less cost to sell. Assets held for sale are no longer amortised or depreciated.

#### 6. Capital Work in Progress and Capital Advances

Cost of assets not ready for intended use, as on balance sheet date, is shown as capital work in progress. Advances given towards acquisition of Property Plant and Equipment outstanding at each balance sheet date are disclosed as Other Non-Current Assets.

#### 7. Impairment of non-financial assets

At each balance sheet date, an assessment is done to determine whether there is any indication of impairment in the carrying amount of the Company's non-financial assets. An impairment loss is recognised whenever the carrying value of an asset or a cash-generating unit exceeds its recoverable amount. Recoverable amount of an asset or a cash-generating unit is the higher of its fair value less costs of disposal and its value in use. An impairment loss, if any, is recognised in the Statement of Profit and Loss in the period in which the impairment takes place. The impairment loss is allocated first to reduce the carrying amount of any goodwill (if any) allocated to the cash generating unit and then to the other assets of the unit, pro rata based on the carrying amount of each asset in the unit.

An assessment is also done at each Balance Sheet date whether there is any indication that an impairment loss recognised for an asset in prior accounting periods may no longer exist or may have decreased. If any such indication exists, the asset's recoverable amount is estimated. The carrying amount of the fixed asset is increased to the revised estimate of its recoverable amount so that the increased carrying amount does not exceed the carrying amount that would have been determined had no impairment loss been recognised for the asset in prior years. A reversal of impairment loss is recognised in the Statement of Profit and Loss for the year.

After recognition of impairment loss or reversal of impairment loss as applicable, the depreciation charge for the asset is adjusted in future periods to allocate the asset's revised carrying amount, less its residual value (if any), on straight line basis over its remaining useful life.

#### 8. Financial Instruments

A financial instrument is any contract that gives rise to a financial asset of one entity and a financial liability or equity instrument of another entity. Financial instruments also include derivative contracts such as forward contracts, futures and currency options.

##### Financial Assets

##### Initial recognition and measurement

All financial assets are recognised initially at fair value plus transaction costs that are attributable to the acquisition of the financial asset, except in the case of financial assets not recorded at fair value through profit or loss. Transaction costs of financial assets carried at fair value through profit or loss are expensed through the Statement of Profit and Loss.

However, trade receivables that do not contain a significant financing component are measured at transaction price.

## Subsequent measurement

For purposes of subsequent measurement, the Company classifies its financial assets in the following measurement categories:

- i. The Company's business model for managing the financial asset and
- ii. The contractual cash flow characteristics of the financial asset.

Based on the above criteria, the Company classifies its financial assets into the following categories:

- i. Financial assets measured at amortised cost
- ii. Financial assets measured at fair value through other comprehensive income (FVTOCI)
- iii. Financial assets measured at fair value through profit & loss (FVTPL)

### i. Financial Assets measured at Amortised cost

This category applies to cash and bank balances, trade receivables, loans and other financial assets of the Company. Such financial assets are measured at amortised cost if both the following conditions are met: The asset is held within a business model whose objective is to hold assets for collecting contractual cash flows, and Contractual terms of the asset give rise on specified dates to cash flows that are solely payments of principal and interest (SPPI) on the principal amount outstanding. Subsequently such financial assets are measured at amortized cost using the Effective Interest Rate (EIR) method.

Under the effective interest method, the future cash receipts are exactly discounted to the initial recognition value using the effective interest rate. The cumulative amortization using the effective interest method of the difference between the initial recognition amount and the maturity amount is added to the initial recognition value (net of principal repayments, if any) of the financial asset over the relevant period of the financial asset to arrive at the amortized cost at each reporting date. The corresponding effect of the amortization under effective interest method is recognized as interest income over the relevant period of the financial asset. The same is included under finance income in the Statement of Profit and Loss.

### ii. Financial Assets measured at FVTOCI

Assets that are held for collection of contractual cash flows and for selling the financial assets, where the assets' cash flows represent solely payments of principal and interest, are measured at fair value through other comprehensive income (FVTOCI). Movements in the carrying amount are taken through OCI, except for the recognition of impairment gains or losses, interest revenue and foreign exchange gains and losses which are recognised in Statement of Profit and Loss. When the financial asset is derecognised, the cumulative gain or loss previously recognised in OCI is reclassified from equity to Statement of Profit and Loss. Interest income from these financial assets is included in other income using the effective interest rate method.

### iii. Financial Assets measured at FVTPL

Assets that do not meet the criteria for amortised cost or FVTOCI are measured at fair value through profit or loss. A gain or loss on a debt investment that is subsequently measured at fair value through Profit or Loss is recognised in the Statement of Profit and Loss in the period in which it arises. Interest income from these financial assets is included in other income.

## Equity Instruments

All equity investments within the scope of Ind-AS 109 are measured at fair value. Equity instruments which are held for trading are classified as at FVTPL. For all other equity instruments, the Company decides to classify the same either as at FVTOCI or FVTPL. The Company makes such election on an instrument-by-instrument basis. The classification is made on initial recognition and is irrevocable.

If the Company decides to classify an equity instrument as at FVTOCI, then all fair value changes on the instrument, excluding dividends, are recognized in the Other Comprehensive Income (OCI). There is no recycling of the amounts from OCI to profit and loss, even on sale of investment. However, the Company may transfer the cumulative gain or loss within equity.

Equity instruments included within the FVTPL category are measured at fair value with all changes recognized in the profit and loss.

## Derecognition

A financial asset is derecognised only when:

- i. the rights to receive cash flows from the financial asset have expired contract is discharged, cancelled or expires.
- ii. Where the entity has transferred an asset, the Company evaluates whether it has transferred substantially all risks and rewards of ownership of the financial asset. In such cases, the financial asset is derecognised. Where the entity has not transferred substantially all risks and rewards of ownership of the financial asset, the financial asset is not derecognised.
- iii. Where the entity has neither transferred a financial asset nor retains substantially all risks and rewards of ownership of the financial asset, the financial asset is derecognised if the Company has not retained control of the financial asset. Where the Company retains control of the financial asset, the asset is continued to be recognised to the extent of continuing involvement in the financial asset.

## Impairment of Financial Assets

The Company applies expected credit loss (ECL) model for measurement and recognition of loss allowance on the following:

- i. Trade receivables
- ii. Financial assets measured at amortized cost (other than trade receivables)
- iii. Financial assets measured at fair value through other comprehensive income (FVTOCI)

In case of trade receivables, the Company follows a simplified approach wherein an amount equal to lifetime ECL is measured and recognized as loss allowance.

In case of other assets (listed as ii and iii above), the Company determines if there has been a significant increase in credit risk of the financial asset since initial recognition. If the credit risk of such assets has not increased significantly, an amount equal to 12-month ECL is measured and recognized as loss allowance. However, if credit risk has increased significantly, an amount equal to lifetime ECL is measured and recognized as loss allowance. Subsequently, if the credit quality of the financial asset improves such that there is no longer a significant increase in credit risk since initial recognition, the Company reverts to recognizing impairment loss allowance based on 12-month ECL.

ECL is the difference between all contractual cash flows that are due to the Company in accordance with the contract and all the cash flows that the Company expects to receive (i.e., all cash shortfalls), discounted at the original effective interest rate.

Lifetime ECL are the expected credit losses resulting from all possible default events over the expected life of a financial asset. 12-month ECL are a portion of the lifetime ECL which result from default events that are possible within 12 months from the reporting date.

ECL are measured in a manner that they reflect unbiased and probability weighted amounts determined by a range of outcomes, taking into account the time value of money and other reasonable information available as a result of past events, current conditions and forecasts of future economic conditions.

As a practical expedient, the Company uses a provision matrix to measure lifetime ECL on its portfolio of trade receivables. The provision matrix is prepared based on historically observed default rates over the expected life of trade receivables and is adjusted for forward looking estimates. At each reporting date, the historically observed default rates and changes in the forward-looking estimates are updated.

ECL allowance recognised (or reversed) during the period is recognized as income/ expense in the Statement of Profit and Loss under the head 'Other expenses'.

#### **Financial Liabilities**

##### **Classification as liability or equity**

Financial liabilities and equity instruments issued by the Company are classified according to the substance of the contractual arrangements entered into and the definitions of a financial liability and an equity instrument.

##### **Initial recognition and measurement**

Financial liabilities are recognised when the Company becomes a party to the contractual provisions of the instrument. Financial liabilities are initially measured at the amortised cost unless at initial recognition, they are classified as fair value through profit and loss. In case of trade payables, they are initially recognised at fair value and subsequently, these liabilities are held at amortised cost, using the effective interest rate method.

##### **Subsequent measurement**

Financial liabilities are subsequently measured at amortised cost using the EIR method. Financial liabilities carried at fair value through profit or loss are measured at fair value with all changes in fair value recognised in the Statement of Profit and Loss. Interest expenses are included in the 'Finance costs' line item.

##### **Derecognition**

A financial liability is derecognised when the obligation under the liability is discharged or cancelled or expires. When an existing financial liability is replaced by another from the same lender on substantially different terms, or the terms of an existing liability are substantially modified, such an exchange or modification is treated as the derecognition of the original liability and the recognition of a new liability. The difference in the respective carrying amounts is recognised in the statement of profit or loss.

##### **Offsetting of financial instruments**

Financial assets and financial liabilities are offset and the net amount is reported in the balance sheet if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, or to realise the assets and settle the liabilities simultaneously.

## **9. Inventory**

Inventories comprise of raw materials, packing materials, work-in-progress, finished goods and stores and spares. Inventories are valued at lower of cost and net realisable value. Costs are ascertained on First in First Out (FIFO) basis. Costs includes cost of purchase and other costs incurred in bringing each product to its present location and condition. In the case of manufactured inventories, cost includes cost of raw materials, packing materials and an appropriate share of fixed and variable production overheads. Fixed production overheads are allocated on the basis of normal operating capacity. Variable production overheads are allocated based on actual use of production facilities.

Net realizable value represents the estimated selling price for inventories in normal course of business, less all estimated costs of completion and costs necessary to make the sale.

Provision is made for cost of obsolescence and other anticipated losses whenever considered necessary.

## 10. Cash and Cash Equivalents

Cash and cash equivalents in the balance sheet includes cash at bank and on hand, book debit balances in cash credit and current accounts, deposits held at call with financial institutions, other short term highly liquid investments, with original maturities less than three months which are readily convertible into cash and which are subject to insignificant risk of changes in value.

For the purpose of the statement of cash flows, cash and cash equivalents, cash and short - term deposits as defined above is net of outstanding bank overdrafts as they are considered an integral part of the Company's cash management.

## 11. Provisions, Contingent Liabilities and Contingent Assets

The Company recognizes a provision when there is a present legal or constructive obligation as a result of a past event that probably requires an outflow of resources and a reliable estimate can be made of the amount of the obligation. Provisions are measured at the present value of management's best estimate of the expenditure required to settle the present obligation at the end of the reporting period. The discount rate used to determine the present value is a pre-tax rate that reflects current market assessments of the time value of money and the risks specific to the liability. The increase in the provision due to the passage of time is recognised as interest expense.

A disclosure for a contingent liability is made when there is a possible obligation or a present obligation that may, but probably will not, require an outflow of resources. Where there is a possible obligation or a present obligation in respect of which likelihood of outflow of resources is remote, no provision or disclosure is made.

A contingent asset is a possible asset that arises from past events and whose existence will be confirmed only by the occurrence or non-occurrence of one or more uncertain future events not wholly within the control of the entity. Contingent assets are not recognised till the realization of the income is virtually certain. However, the same are disclosed in the financial statements where an inflow of economic benefit is probable.

## 12. Revenue Recognition

Revenue from contracts with customers is recognized on transfer of control of promised goods to customers for an amount that reflects the consideration to which the Company is expected to be entitled to in exchange for those goods or services. Revenue excludes taxes or duties collected on behalf of the government.

Revenue towards satisfaction of a performance obligation is measured at the amount of transaction price allocated to that performance obligation. Revenue is recognized only to the extent that it is highly probable that the amount will not be subject to significant reversal when uncertainty relating to its recognition is resolved.

### *Sale of Products*

Revenue from sale of products is recognized when the control on the goods has been transferred to the customer. The performance obligation in case of sale of products is satisfied at a point in time i.e., when the material is shipped to the customer or on delivery to the customer, as may be specified in the contract. The Company recognizes revenues on the sale of products, net of returns, discounts (if any) and amounts collected on behalf of third parties (such as GST).

### *Rendering of Services*

Income from services rendered is recognised based on agreements/arrangements with the customers as the service is performed and there are no unfulfilled obligations.

### *Interest Income*

Interest income is recognized using the effective interest rate (EIR) method.

## 13. Employee Benefits

### i. Short Term Employee Benefits

All employee benefits payable wholly within twelve months of rendering the service are classified as short-term employee benefits and they are recognized in the period in which the employee renders the related service. The Company recognizes the undiscounted amount of short-term employee benefits expected to be paid in exchange for services rendered as a liability (accrued expense) after deducting any amount already paid.

### ii. Post-Employment Benefits

#### ➤ Defined Contributions plan

##### **Provident Fund and Employee State Insurance Scheme**

Defined contribution plans are Provident Fund Scheme and Employee State Insurance Scheme. The Company contributes to the Government administered provident funds on behalf of its employees.

##### **Recognition and measurement of defined contribution plans**

The Company recognizes contribution payable to a defined contribution plan as an expense in the Statement of Profit and Loss when the employees render services to the Company during the reporting period. If the contributions payable for services received from employees before the reporting date exceeds the contributions already paid, the deficit payable is recognized as a liability after deducting the contribution already paid. If the contribution already paid exceeds the contribution due for services received before the reporting date, the excess is recognized as an asset to the extent that the prepayment will lead to, for example, a reduction in future payments or a cash refund.



➤ **Defined Benefit plans:**

**Gratuity scheme**

The Company operates a defined benefit gratuity plan for employees. The Company contributes to a separate entity (a fund), towards meeting the Gratuity obligation.

**Recognition and measurement of defined benefit plans:**

The cost of providing defined benefits is determined using the Projected Unit Credit method with actuarial valuations being carried out at each reporting date. The defined benefit obligations recognized in the Balance Sheet represent the present value of the defined benefit obligations as reduced by the fair value of plan assets, if applicable. Any defined benefit asset (negative defined benefit obligations resulting from this calculation) is recognized representing the present value of available refunds and reductions in future contributions to the plan.

All expenses represented by current service cost, past service cost, if any, and net interest on the defined benefit liability / (asset) are recognized in the Statement of Profit and Loss. Remeasurements of the net defined benefit liability / (asset) comprising actuarial gains and losses and the return on the plan assets (excluding amounts included in net interest on the net defined benefit liability/asset), are recognized in Other Comprehensive Income. Such remeasurements are not reclassified to the Statement of Profit and Loss in the subsequent periods.

The Company presents the above liability/(asset) as current and non-current in the Balance Sheet as per actuarial valuation by the independent actuary.

**iii. Other Long-Term Employee Benefit**

Entitlements to annual leave and sick leave are recognized when they accrue to employees. Sick leave can only be availed while annual leave can either be availed or encashed subject to a restriction on the maximum number of accumulations of leave. The Company determines the liability for such accumulated leaves using the Projected Accrued Benefit method with actuarial valuations being carried out at each Balance Sheet date. Actuarial gains and losses in respect of such benefits are charged to Statement of Profit and Loss in the period in which they arise.

**iv. Ind AS 19 – Plan Amendment, Curtailment or Settlement**

As per the amendment to Ind AS 19 if there is a change in the plan assets, amendment, curtailment or settlement occurs, then the current service cost and the net interest for the period after the re-measurement are determined using the assumptions used for the re-measurement.

**14. Income Taxes**

Income tax expense comprises current tax expense and deferred tax expense. It is recognised in profit or loss except to the extent that it relates to items recognised directly in equity or in OCI. In which case, the tax is also recognized directly in equity or other comprehensive income, respectively.

**Current tax:**

Current tax is the amount of income taxes payable in respect of taxable profit for a period. Taxable profit differs from 'profit before tax' as reported in the Statement of Profit and Loss because of items of income or expense that are taxable or deductible in other years and items that are never taxable or deductible under the Income Tax Act, 1961.

Current tax is measured using tax rates that have been enacted by the end of reporting period for the amounts expected to be recovered from or paid to the taxation authorities.

Management periodically evaluates positions taken in tax returns with respect to situations in which applicable tax regulation is subject to interpretations and establishes provisions where appropriate.

**Deferred tax:**

Deferred tax is recognized on temporary differences between the carrying amounts of assets and liabilities in the financial statements and the corresponding tax bases used in the computation of taxable profit under Income Tax Act, 1961.

Deferred tax liabilities are generally recognized for all taxable temporary differences. However, in case of temporary differences that arise from initial recognition of assets or liabilities in a transaction (other than business combination) that affect neither the taxable profit nor the accounting profit, deferred tax liabilities are not recognized. Also, for temporary differences if any that may arise from initial recognition of goodwill, deferred tax liabilities are not recognized.

Deferred tax assets are generally recognized for all deductible temporary differences to the extent it is probable that taxable profits will be available against which those deductible temporary difference can be utilized. In case of temporary differences that arise from initial recognition of assets or liabilities in a transaction (other than business combination) that affect neither the taxable profit nor the accounting profit, deferred tax assets are not recognized.

The carrying amount of deferred tax assets is reviewed at the end of each reporting period and reduced to the extent that it is no longer probable that sufficient taxable profits will be available to allow the benefits of part or all of such deferred tax assets to be utilized.

Deferred tax assets and liabilities are measured at the tax rates that have been enacted or substantively enacted by the Balance Sheet date and are expected to apply to taxable income in the years in which those temporary differences are expected to be recovered or settled.

### **Presentation of current and deferred tax:**

Current and deferred tax are recognized as income or an expense in the Statement of Profit and Loss, except when they relate to items that are recognized in Other Comprehensive Income, in which case, the current and deferred tax income/ expense are recognized in Other Comprehensive Income.

The Company offsets current tax assets and current tax liabilities, where it has a legally enforceable right to set off the recognized amounts and where it intends either to settle on a net basis, or to realize the asset and settle the liability simultaneously. In case of deferred tax assets and deferred tax liabilities, the same are offset if the Company has a legally enforceable right to set off corresponding current tax assets against current tax liabilities and the deferred tax assets and deferred tax liabilities relate to income taxes levied by the same tax authority on the Company.

As per the Appendix to Ind AS 12, the Company needs to assess whether it is probable that a tax authority will accept an uncertain tax treatment used or a treatment which is being proposed to be used in its income tax filings.

## **15. Foreign Currency Transactions**

### **i. Functional and Presentation currency**

The Company's financial statements are prepared in Indian Rupees (INR "₹") which is also the Company's functional currency.

### **ii. Transactions and balances**

Foreign currency transactions are recorded on initial recognition in the functional currency using the exchange rate at the date of the transaction.

Monetary assets and liabilities denominated in foreign currencies are translated into the functional currency at the exchange rate at the reporting date. Non-monetary items that are measured based on historical cost in a foreign currency are translated using the exchange rate at the date of the initial transaction. Non-monetary items that are measured at fair value in a foreign currency are translated using the exchange rate at the date the fair value is determined.

Exchange differences arising on the settlement or translation of monetary items are recognized in profit or loss in the year in which they arise except for the qualifying cash flow hedge, which are recognised in OCI to the extent that the hedges are effective.

## **16. Government Grant and subsidies**

Grants in the nature of subsidy which are non-refundable are credited to the statement of profit and loss, on accrual basis, where there is reasonable assurance that the Company will comply with all the necessary conditions attached to them.

Grants in the nature of subsidy which are refundable are shown as liabilities in the Balance Sheet.

## **17. Derivative Financial instruments and hedge accounting**

The Company uses derivative financial instruments, such as forward currency contracts, to hedge its foreign currency risks and interest rate risks respectively. Such derivative financial instruments are initially recognised at fair value on the date on which a derivative contract is entered into and are subsequently re-measured at fair value at the end of each reporting period. The accounting for subsequent changes in fair value depends on whether the derivative is designated as a hedging instrument, and if so, the nature of item being hedged and the type of hedge relationship designated.

Derivatives are carried as financial assets when the fair value is positive and as financial liabilities when the fair value is negative.

### **Forward exchange contracts**

The Company enters into forward exchange contracts in nature of currency swaps and interest rate swaps to hedge against its foreign currency exposures relating to the underlying transactions and firm commitments. The Company does not enter into any derivative instruments for trading or speculative purposes.

The forward exchange contract is marked to market (MTM) and the gain/ loss on the same is recognised as an expense/income over the life of the contract. Exchange differences on such contracts are recognised in the Statement of Profit and Loss in the period in which the exchange rates change. Any Profit or Loss arising on cancellation or renewal of such forward exchange contract is also recognised as income or expense for the period.

## **18. Offsetting of financial instruments**

Financial assets and financial liabilities are offset and the net amount is reported in the balance sheet if there is a currently enforceable legal right to offset the recognised amounts and there is an intention to settle on a net basis, to realise the assets and settle the liabilities simultaneously.

## **19. Research and Development**

Expenditure on research is recognized as an expense when it is incurred. Expenditure on development which does not meet the criteria for recognition as an intangible asset is recognized as an expense when it is incurred.

Items of property, plant and equipment and acquired intangible assets utilized for Research and Development are capitalized and depreciated in accordance with the policies stated for Property, Plant and Equipment and Intangible Assets.

## 20. Borrowing Cost

Borrowing cost includes interest, amortization of ancillary costs incurred in connection with the arrangement of borrowings and exchange differences arising from foreign currency borrowings to the extent they are regarded as an adjustment to the interest cost.

Borrowing costs, if any, directly attributable to the acquisition, construction or production of an asset that necessarily takes a substantial period of time to get ready for its intended use or sale are capitalized, if any. All other borrowing costs are expensed in the period in which they occur.

In accordance with the amended Ind AS 23 Borrowing Cost, if any specific borrowing remains outstanding after the related asset is ready for its intended use or sale, that borrowing becomes part of the funds that an entity borrows generally when calculating the capitalisation rate on general borrowings.

## 21. Exceptional items

Exceptional items refer to items of income or expense within the income statement from ordinary activities which are non-recurring and are of such size, nature or incidence that their separate disclosure is considered necessary to explain the performance of the Company and to assist users of financial statements in making projections of future financial performance.

## 22. Events after Reporting date

Where events occurring after the Balance Sheet date provide evidence of conditions that existed at the end of the reporting period, the impact of such events is adjusted within the financial statements. Otherwise, events after the Balance Sheet date of material size or nature are only disclosed.

## 23. Dividend

The Company recognises a liability for any dividend declared but not distributed at the end of the reporting period, when the distribution is authorised and the distribution is no longer at the discretion of the Company on or before the end of the reporting period. As per Corporate laws in India, a distribution is authorized when it is approved by the shareholders. A corresponding amount is recognized directly in equity.

## 24. Earnings Per Share

Basic earnings per share is calculated by dividing the profit or loss for the period attributable to the equity shareholders by the weighted average number of equity shares outstanding during the period.

For the purpose of calculating diluted earnings per share, the profit or loss for the period attributable to the equity shareholders and the weighted average number of equity shares outstanding during the period is adjusted to take into account:

- The after income tax effect of interest and other financing costs associated with dilutive potential equity shares, and
- Weighted average number of additional equity shares that would have been outstanding assuming the conversion of all dilutive potential equity shares.

## 25. Segment Reporting

The Company has identified Plastic Containers as its single primary reportable segment in accordance with the requirements of Ind AS 108 - Operating Segments.

### 3. Recent pronouncements: Ministry of Corporate Affairs ("MCA") notifies new standards or amendments to the existing standards under Companies (Indian Accounting Standards) Rules as issued from time to time. On March 31, 2023, MCA amended the Companies (Indian Accounting Standards) Amendment Rules, 2023, as below:

Ind AS 1 - Presentation of Financial Statements - This amendment requires the entities to disclose their material accounting policies rather than their significant accounting policies. The effective date for adoption of this amendment is annual periods beginning on or after April 1, 2023. The Company has evaluated the amendment and the impact of the amendment is insignificant in the financial statements.

Ind AS 8 - Accounting Policies, Changes in Accounting Estimates and Errors - This amendment has introduced a definition of 'accounting estimates' and included amendments to Ind AS 8 to help entities distinguish changes in accounting policies from changes in accounting estimates. The effective date for adoption of this amendment is annual periods beginning on or after April 1, 2023. The Company has evaluated the amendment and there is no impact on its financial statements.

Ind AS 12 - Income Taxes - This amendment has narrowed the scope of the initial recognition exemption so that it does not apply to transactions that give rise to equal and offsetting temporary differences. The effective date for adoption of this amendment is annual periods beginning on or after April 1, 2023. The Company has evaluated the amendment and there is no impact on its financial statement.

Term loan from HDFC Bank was repayable in 16 quarterly instalments over a period of five years including a moratorium of one year commencing from the date of first draw down. The loan carried interest based on One year Marginal Cost of Lending Rate (MCLR) (adjustable annually) plus Nil spread. The effective rate of interest was 7.25 % p.a. (Previous year 7.20%). The loan has been repaid during the current year including the moratorium of loan and interest availed during the covid period based on RBI regulations.

**b) Rupee Term Loan from Bank ₹ 1,125 lakhs (March 31, 2022: ₹ 2,250 lakhs)**

Term loan from Kotak Mahindra Bank is repayable in 16 quarterly instalments over a period of six years including a moratorium of two years commencing from the date of initial draw down. The draw down up to April 2018, of ₹ 2,700 lakhs is at fixed interest rate of 8.35 % p.a whereas the subsequent tranches are based on MCLR rates which averaged to 8.05 % p.a. The loan is secured by exclusive first charge on plant & machinery and charge on immovable fixed assets comprising of land and building at Vizag.

**ii) Working Capital Loan under Emergency Credit line Guarantee Scheme from Bank ₹ 1,056.41 lakhs ( March 31, 2022: ₹ 1,400 lakhs)**

Working capital loan from HDFC Bank under Emergency Credit Line Guarantee Scheme (ECLGS) announced by the Government of India is repayable over 5 years in 48 monthly instalments (including moratorium of one year). The loan carries interest based on External Benchmark Lending Rate (EBLR) (adjustable every 3 months or at such intervals as permissible under RBI guidelines) plus 2.75% spread. The present effective rate of interest is 9.00% p.a.(Previous year 6.75% p.a.) The facility is covered by 100% guarantee from National Credit Guarantee Trustee Company Ltd (Ministry of Finance, Government of India) and an extension of second ranking charge over existing primary and collateral securities including mortgages created in favour of the bank.

**iii) Other Borrowings - Secured**

Working capital facilities including cash credit from banks are secured on first charge basis by way of hypothecation of inventories and book debts of specific units and collaterally secured by hypothecation of specific plant and machinery and equitable mortgage on land and building of specific units. The borrowings carries interest @ 6.75% to 8.70% p.a. ( Previous year 6.75% to 8.25 % p.a.).

**iv) Other Borrowings - Unsecured**

(a) Corporate card is unsecured facility provided by the banks repayable within 45 days for a convenience fee 0.78 % and 51 days for a convenience fee 0.95% (previous year 0.95%) respectively. The facility is used for making vendor and tax payments.
