Robbed from Kolhapur bank

Rs 1 crore was stolen from a cooperative bank in the early hours of the night, police said. The incident happened in the Kale village branch of the bank's Panhala taluka, a police official said. "The robbers used gas masks and they then disconnected the CCTV camera network and took away the cash. The estimates suggest is cumulatively Rs 1 crore. It possibly happened in the early hours of the night," he said.
