

### L&T Defence conferred Green Channel Status by Ministry of Defence

**Mumbai, December 21, 2020:** L&T Defence, the defence arm of Larsen & Toubro, India's leading engineering, procurement and construction projects, manufacturing, defence and services conglomerate, has been awarded the coveted 'Green Channel Status' for major Naval weapon delivery systems from the Directorate General Quality Assurance (DGQA), Ministry of Defence (MoD), Government of India.

The grant of Green Channel Certificate to a firm provides deemed registration status, waiver of pre-dispatch inspection and acceptance of stores under supplying firm's guarantee or warranty against the contracts concluded by various procurement agencies under MoD.
