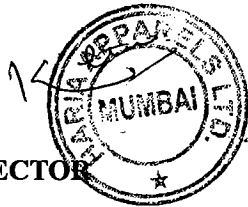



**Review Report to the Board of Directors of Haria Apparels Limited**
