## Sub: <u>Update on divestment of entire equity holding in its indirect wholly owned</u> <u>subsidiary, Sintex NP SAS</u>

In furtherance to our letter Ref No: SPTL/NSE/BSE/2019-20 dated 19<sup>th</sup> July, 2019 with respect to divestment of entire equity holding of its indirect wholly owned subsidiary, Sintex NP SAS, we hereby inform you that on 9<sup>th</sup> August, 2019, the Company, through its indirect wholly-owned subsidiary, Sintex Holdings BV (the "Seller"), has entered into a Share Purchase Agreement (the "SPA") with respect to sale of 100% equity stake in its indirect wholly owned subsidiary, Sintex NP SAS, a French société par actions simplifiée, to Xtech Invest SAS, a French société par actions simplifiée a assoicie unique, in the course of being incorporated, owned by a consortium of private equity entities (as detailed below).

Sintex-BAPL, a subsidiary of the Company, is also party to the Share Purchase Agreement in order to guarantee the commitments to be taken by the Seller under the SPA.
