# Father-son duo axes three to death over property, held

**Couple and their eleven-year-old grandson among deceased**

Days after Raisen chilling triple murder, a similar case of gruesome killing has come to fore in Harda district where three persons including a woman and minor boy were hacked to death by relatives. The incident occurred in Bediya Kalan village under Sirali police station on Sunday night. Old property dispute is reported to be main reason

behind the triple murder, said police. Police have arrested two persons - Ramkrishna Likhore, 35 and his father Punamchand Likhore, 55, in connection with the murders of their relatives.

Ramkrishna along with his father attacked his uncle Bhayalal Lakhore, 55, aunt Kusum Bai, 52, and their grandson Aditya, 11, with an axe and killed them on the spot.

After the villagers informed about the gruesome killings, police reached the spot and ensured the safety of other members of the family. Thereafter police arrested the two accused. Heavy police force was deployed in

### Absconding accused falls in police net

Meanwhile, police have arrested the man accused of killing three members of his family in Raisen on last Wednesday night. Infidelity of his wife had thrown the man in rage and which resulted in killing of the woman and his patents. The accused, Jitendra Puraviya, 35, after hacking to death his parents Sharada and Jalam Singh and wife Sunita had fled.

SHO Bareilly (Raisen) Kuwar Singh Mukati said, that Jitendra was arrested from Narmada ghat in Rewakhedi. Jitendra in his statement

Talaiya police have nabbed a Rajasthan-based man involved in duping banks using ATM cards at different locations of the country.

cards and while withdrawing money they would disconnect power which would not register the transaction and later they would request for refund and would get it.

SHO Talaiya police Indraj Singh Rajput said that during intensive check conducted due to festive season and Lok Sabha elections, two men with carry bags were detained. The police recovered 41 ATM

cards from their possession.

## Private security agencies asked to submit details by May 31

Directors of private security agencies have been asked to submit their details in a proforma before May 31.

The instructions were given by ADG Anil Kumar here on Monday during a meeting with private security directors. The aim of the meeting was to inform them about the

Private Security Act 2005 and Personal Security Act 2012.

The agencies were asked to follow the guideline of the acts and submit information every three months.

The ADG has asked directors to secure the rights of security guards, provide them proper training, provident fund and facility of ESIC. The ADG also asked them to obtain character certificate of

every guard from the respective police station. They were instructed not to take extra duty hours from the guards. The guards shall be given at least minimum wages and on time.

The government has issued licences to 1,034 security agencies in the state. Agencies having more than 200 registered guards were called for the meeting.

## Three held for framing victims in fake flesh trade, extorting money

Crime branch busted a gang of miscreants extorting money after framing victims in fake flesh trade racket.

Police arrested three people, including two girls. One of the culprits, who was in police dress, absconded. One of the arrested is identified as Bhupesh Rana, a resident of E-8, Arera Colony.

According to police, 69-year-old retired engineer, who became victim of the gang, has lodged a complaint with crime branch stating that he received a phone call from an unknown lady who called him at DB Mall and introduced herself. Later she called him at a flat in Talaiya Mandir locality. When he visited there, she took him to a deserted flat where a girl was already waiting. He further stated that during

talks, two men, one of them dressed as policeman, appeared on the scene and started blaming him for running a flesh trade.

He said that they forcefully took photographs in nude position and started blackmailing him. Initially, they demanded Rs 6 lakh but later agreed on Rs 6,000 which he had.

The victim said when the accused disappeared from the flat he contacted the crime branch and lodged a complaint.

Police said that they took complainant along with them and raided many places to find out the accused but all in vain. Later, they arrested one of accused who was roaming with his friend near RTO office area. The accused was identified as Bhupesh Rana.

During interrogation, Rana confessed his crime and revealed details about the two girls who were also arrested.

## Instructions given for better traffic management, reduce road accidents

**BHOPAL:** Divisional Commissioner Kalpana Shrivastava has instructed officials to take steps for better traffic management with proper maintenance of automatic traffic signals at squares to check road accidents in the state capital.

She was addressing a meeting here on Monday.

She instructed traffic police to work like nodal agency in this regard. IG Jaideep Prasad, Collector Sudam Khade, DIG Irshad Wali, BMC commissioner B Vijay Dutta were also present in the meeting. Divisional commissioner instructed officials of the Intelligent Transport Management System and city surveillance for better maintenance of traffic signals and squares. Suggestions have been made to address various factors affecting traffic like parking lots, encroachment and dividers.

Instructions have also been given to take strict action against vehicle owners for parking vehicles on side of roads.

अशोक गाईन थाना क्षेत्र में 13 साल के मासूम का अपहरण और फिर चाकू से हमला करने का मामला सामने आया है। पुलिस से बेखोफ बदमाश ऑटो से मासूम का अपहरण कर ले गए। दिनभर ऑटो के अंदर उसे पीटते रहे। सड़क पर मुस्तेदी का दावा करने वाली पुलिस को भनक तक नहीं लगी और बदमाश शहर के बाद मासूम को सीहोर के जंगल ले गए। फिर देर शाम मासूम के दोनों पैरों की चाकू से नसें काट कर उसी जगह फेंक गए, जहां से अपहरण किया था। अपहरण की वजह बसों में पानी बेचना बताया है था। प्रभारी उमेश यादव ने बताया कि 13 वर्षीय शांकिर पिता लिकायत छोटा चंबल में रहता है। वह अपनी मां आमना के साथ प्रभात चौराहे पर बसों में पानी बेचता है। वहीं बड़ा चंबल निवासी हिस्ट्रीशूटर बदमाश समीर बच्चा ठेला लगाता है, वह भी पानी पाउच और कोल्ड-ड्रिंक बेचता है। बसों में पानी बेचने पर रविवार दोपहर समीर ने अपने पिता सलीम, शोएल और साथी अरशान और भाई इब्राहिम के साथ मिलकर शांकिर की मां के साथ मारपीट कर दी। इसके बाद समीर ने मासूम शांकिर को एक ऑटो से अहभरण कर लिया। उस समय बदमाश के साथ उसका पिता सलीम, शोएल और अरशान था। चारों उसे

बिलखिरिया की तरफ ले गए, जहां मारपीट करते रहे। वहां से 6 नंबर बस स्टॉप से उसे लेकर सीहोर पहुंचे, जहां चारों ने मासूम से कहा कि यह सीहोर का जंगल है। यहाँ मार के फेंक देंगे। लड़का आने पर छोड़ दिया मासूम ने बताया है कि चारों बदमाश उसे दिनभर ऑटो के अंदर पीटते रहे। लेकिन सड़क पर चैंकिंग के नाम पर नहीं लगी, अपहरण का खुलासा होने के बाद रात साढ़े 9 बजे हिस्ट्रीशूटर बदमाश समीर और उसके भाई इब्राहिम को पुलिस ने हिरासत में ले लिया। बदमाश समीर बच्चा का कहना था कि वह सीहोर के जंगल में बच्चे की (जिरहा) कुर्बानी करने वाले थे, लेकिन उसके मासूमपन को देख दया आ गई। फिर उसके पैरों की नसें काट दी। पुलिस ने मां आमना को शिकायत पर चारों के खिलाफ अपहरण और मारपीट समेत हत्या के प्रयास की धाराओं के तहत प्रकरण दर्ज किया है।
