Yoyogi Seminar Selects TCS iON PAPER to Transform Spoken English Tests in Japan

Tata Consultancy Services' New Device Will Be Used to Distribute Question Papers to Classrooms without Internet and to Remotely Evaluate Candidate Responses

TOKYO | MUMBAI, February 28, 2019: Tata Consultancy Services (TCS) (BSE:532540, NSE:TCS), a leading global IT services, consulting and business solutions organization, announced that Sapix Yozemi Group (Yoyogi Seminar), a Japanese cram school chain, has selected TCS iON PAPER to transform the conduct of its spoken English tests and evaluation of candidate responses.

Spoken English tests are increasingly becoming part of entrance exams for many universities and high schools in Japan. The University Admission Common Test, which will replace the current National Center Test in 2021, is expected to include spoken English. To prepare students ahead of time, Yoyogi Seminar has included speaking assessments in all its future tests.
