Sub: Request for re-classification under Regulation 31A of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 (the "SEBI Listing Regulations") from the 'promoter' category to 'public' category of Sree Jayalakshmi Auto Spin Limited (the "Company").

Dear Sir/Ma'am,

I, K.V. Prabhakar is disclosed as one of the promoters of the Company in the shareholding pattern filed by the Company with the BSE Limited in accordance with the SEBI Listing Regulations, and I now wish to re-classify myself from Promotor and Promotor Group category to Public in accordance with regulation 31 A of the SEBI LODR Regulations.

As on the date of this request letter, I am not directly or indirectly, associated with the business of the Company and do not have any influence over the business and policy decisions made by the Company. Further, I am neither involved in the day-to-day activities of the Company, nor do I exercise any kind of control over the affairs and working of the Company. Further I do not have any special rights in the Company through any formal or informal arrangements including through any shareholder agreement. Accordingly, I request to be reclassified from the 'promoter' category to the 'public' category of shareholders of the Company.

It is hereby confirmed that I am eligible for such re-classification as 'public' shareholders and satisfy the conditions set out in Regulation 31A of the SEBI Listing Regulations and any other applicable laws. In connection with my request for re-classification, I hereby confirm and certify that:

1. I, along with the person related to me (as defined under sub-clauses (ii), (iii) and (iv) of clause (pp) of sub regulation (1) of Regulation 2 of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018)-
  - a. do not, together, hold more than 10% (ten percent) of the total voting rights in the Company;
  - b. do not exercise control over the affairs of the Company, directly or indirectly;
  - c. do not have any special rights with respect to the Company through formal or informal arrangements including through any shareholder agreements;
  - d. are not represented on the board of directors of the Company (including through nominee director);
  - e. are not acting as a key managerial person in the Company;
  - f. are not 'wilful defaulters' as per the Reserve Bank of India Guidelines; and
  - g. are not fugitive economic offenders.



2. There is no pending regulatory action against me;
3. I shall continue to comply with the conditions mentioned at sub-clauses (i), (ii) and (iii) of clause (b) of Regulation 31 A (3) of the SEBI LODR Regulations at all times from the date of reclassification, failing which, I shall be automatically be reclassified as ' promoter' of the Company;
4. I shall comply with the conditions mentioned at sub-clauses (iv) and (v) of clause (b) of Regulation 31 A (3) of the SEBI LODR Regulations for a period of not less than three years from the date of reclassification, failing which, I shall be automatically be reclassified as ' promoter' of the Company.
5. Further, as on date, I, along with the person related to me (as defined under sub-clauses (ii), (iii) and (iv) of clause (pp) of sub-regulation (l) of Regulation 2 of Securities and Exchange Board of India (Issue of Capital and Disclosure Requirements) Regulations, 2018 do not, together, hold more than 1% (one percent) of the total voting rights in the Company.

I, hereby request you to consider my request for re-classification from 'promoter' category to 'public' category and take all necessary steps, including filing the requisite application to the stock exchange, in terms of Regulation 31A of the SEBI Listing Regulations. I shall extend all necessary cooperation including providing all necessary information/documents as may be required with respect to the reclassification, as and when required, to facilitate the process.
