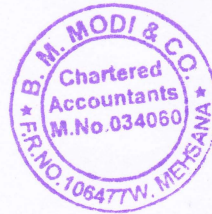
Review Report to the Board of Directors of Promact Impex Limited (formerly known as Promact Plastics Limited)
