Pursuant to Regulation 30 of the Listing Regulations, we wish to submit that Zomato Chile SpA ("**ZM Chile**"), a wholly owned subsidiary of Zomato Limited ("the **Company**") located in Chile has been liquidated w.e.f. 29th September, 2023.

Further, as disclosed in our red herring prospectus dated July 6, 2021 and prospectus dated July 19, 2021, ZM Chile did not have any active business operations and was under the process of liquidation. It may be further noted that the closure of ZM Chile does not affect the turnover/revenue of the Company.
