LIMITED REVIEW REPORT

Review Report to the Board of Directors of Promact Impex Limited (formerly known as Promact Plastics Limited)

We have reviewed the accompanying statement of unaudited financial results of **Promact Impex Limited (formerly known as Promact Plastics Limited)** ("the Company") for the Quarter and Half Year ended 31st December, 2018 ("the Statement") being submitted by the Company pursuant to the requirement of Regulation 33 of the SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015 as modified by Circular No. CIR/CFD/FAC/62/2016 dated July 5, 2016. This Statement, which is the responsibility of the Company's Management and approved by the Board of Directors, has been prepared in accordance with the recognition and measurement principles laid down in Indian Accounting Standard 34 "Interim Financial Reporting" ("Ind AS 34") prescribed under Section 133 of the Companies Act, 2013 ("the Act") read with relevant rules issued thereunder and other accounting principles generally accepted in India.
