We would like to inform you that the Board of Directors of the Company at its meeting held today i.e. August 07, 2018:

- 1. Approved the appointment of Mr. Milind Narendra Patel as Group Chief Executive Officer of the Company and also designated him as Key Managerial Personnel w.e.f. August 07, 2018.
- 2. Approved the proposal for re-classification of existing Promoters and Promoter Group into the Public Shareholder category, in terms of request received from them, and to seek approval of shareholders of the Company in this regard. The shareholders' approval will be sought in due course of time.

Further, Mr. Ashok Mehta has stepped down from the position of Interim CEO of the Company and consequently ceased to be Key Managerial Personnel of the Company w.e.f. August 07, 2018. Now his proposed appointment on the Board of Directors of the Company will be in capacity of **"Non-Executive Non-Independent Director"** in place of "Whole Time Director & CEO" as intimated earlier. Please also note that his appointment on the Board of the Company is subject to the approval of the Reserve Bank of India ("RBI") for which application has already been made by the Company to RBI on February 21, 2018 and same is pending as on date. The Company will be filing an amendment application with the RBI in this regard.

Please note that Mr. Milind Narendra Patel and Mr. Ashok Mehta are not related to any of the directors on the Board of the Company.

Further, Mr. Ashok Mehta is not debarred from accessing the capital market and/or restrained from holding position of Director in any listed company by virtue of any SEBI Order.
