## IITB student's suicide: Family says Police must probe caste-based discrimination angle

MUMBAI, MAY 12 --/ Ramesh Solanki, the father of Indian Institute of Technology Bombay (IITB) student Darshan Solanki who died allegedly by suicide, said on Thursday that the Mumbai police's Special Investigation Team (SIT) should investigate the caste-based discrimination angle in the case.

Solanki and his family members along with former Mumbai University vice chancellor and MP Bhalchandra Mungekar held a press conference here. Solanki, who hailed from Ahmedabad and was a first-year student of the B Tech (Chemical) course, died after allegedly jumping off the seventh floor of a hostel building on the IITB campus in suburban Powai on February 12, a day after the semester exams ended. The SIT should not investigate the case only on the basis of the purported suicide note found in Darshan's hostel room but also look into the caste-based discrimination faced by Darshan, said Ramesh Solanki. "We have submitted all related evidence to SIT officials," he said. A roommate of Darshan's was arrested in the case for alleged abetment of suicide. He is now out on bail. (PTI)

## 'Jan Sangharsh Yatra': Sachin Pilot calls for 'change' in RPSC, March enters 2nd day

JAIPUR, MAY 12 --/ Congress leader Sachin Pilot on Friday called for a "change" in the entire structure of the Rajasthan Public Service Commission following the arrest of a commission member in the paper leak case. Pilot was addressing his supporters who had gathered for his 'Jan Sangharsh Yatra', which entered its second day, at the toll plaza in Kishangarh of Ajmer district. "Recently, an RPSC (Rajasthan Public Service Commission) member was arrested. It was for the first time in history that a member of the RPSC was arrested in a paper leak case. There is a need to

change the entire structure. "My struggle is for the people and I said that I will walk from the RPSC office in Ajmer to Jaipur and I will be in the public and get their blessings," Pilot said. RPSC member Babul Kataria, one of the three people arrested last month in connection with the 2022 teacher recruitment paper leak case, had allegedly received Rs 60 lakh for leaking the question paper, a senior police official had said. Pilot on Thursday began a 125-kilometre foot march from Ajmer to Jaipur, challenging Chief Minister Ashok Gehlot and the Congress top brass ahead of

the assembly elections in Rajasthan. In Kishangarh, he was welcomed by a large number of supporters who cheered for him and showered him with flowers. The five-day yatra mounts further pressure on the party leadership as it hopes to retain the state in the elections at the end of the year. Apart from corruption, the yatra focuses on cases of paper leaks in government recruitment exams. The RPSC is based in Ajmer, which is also the constituency from where Pilot was elected to Parliament in the past. The issue is expected to come up

at a meeting being taken by Sukhjinder Singh Randhawa, the Congress Rajasthan in-charge, in Delhi on Friday. The march comes days after Gehlot accused the MLAs involved in the 2020 revolt of taking money from the BJP. Pilot and 18 other Congress MLAs had then sought a leadership change in Rajasthan. He was sacked as the party's state unit president and the deputy chief minister. The two Congress strongmen in Rajasthan have been at loggerheads over the post of chief minister ever since the party formed the government in 2018. (PTI)

## G20 will be held in peaceful manner, says Kashmir's top Police official

SRINAGAR, MAY 12 --/ Amid terror threats emerging ahead of the crucial G20 meeting, the top cop of the Kashmir Valley took a surprise round of the city during the night to check the preparedness of the police force and said night-and-day domination by security forces would be ensured to make the prestigious programme a grand success.

Passing through the lanes and bylanes of the interior city, Additional Director General of Police (Kashmir Range) Vijay Kumar reached a checkpoint at Panthachowk, an area always bustling with traffic as it forms part of the National Highway connecting the Valley with the rest of the country. A 1997-batch IPS officer, Kumar took time to stand with his jawans who have been tirelessly maintaining tight vigil along the crucial highway, a possible route for terrorists to enter the city.

Kumar, who was accompanied by Senior Superintendent of Police Rakesh Balwal, found out about the difficulties of the personnel besides guiding them in performing their job in pressing circumstances. "This is a high-pressure job but, in the end, we have to be 100 per cent alert. Any failure can prove costly," Kumar told the police personnel on duty. Talking to PTI Video, Kumar said the police force is completely

geared up to meet any challenge. "Generally, we have a naka (checkpoint) for 365 days but whenever an important event happens, every one of us is on the roads to ensure that people sleep peacefully. "The number of checkpoints has definitely increased and many of my senior officers are moving around the city in the last 15 days. Today, I have come out myself to boost their morale and stand next to my jawans on the road," Kumar said.

He said patrolling is part of maintaining night domination of the areas and helps in countering any threat of a terrorist sneaking into the city from South Kashmir. He accepted that there is a threat from terror groups in view of the forthcoming G20 meeting. "Obviously, the threat is there but what are we here for? Let us not forget the motto of J-K Police that says 'A saga of sacrifice and courage'.

Nothing untoward will happen," Kumar said. Kashmir will host the third G20 tourism working group meeting from May 22 to 24. The first working group meeting on tourism was held at the Rann of Kutch in Gujarat in February and the second one in West Bengal's

Siliguri in April. This is the first international meeting being held in Kashmir after the abrogation of Article 370 and the bifurcation of the erstwhile state into two Union Territories - Jammu and Kashmir and Ladakh. Kumar also went into the interiors of the Nowgam area in Srinagar where the threat, mainly from the banned Jaish-e-Mohammed terror group, has been higher. He met the police and CRPF personnel posted there and took stock of the situation.

During his visit to the area, Kumar pointed to an under-construction building and directed the officers to post a sniper there to ensure that the eventuality of a suicide terror attack is averted. The Valley's top police officer also pointed out that women cops were also present in the likelihood that female passengers need to be searched. "We are religiously following all the Standard Operating Procedures and are hopeful that the event will pass off peacefully," Kumar said. He also said some preventive arrests of overground workers and suspects were made as a precautionary measure. (PTI)

## 'Taarak Mehta' actor accuses producer, 2 others of sexual harassment; showmakers call allegations 'baseless'

MUMBAI, MAY 12 --/ "Taarak Mehta Ka Ooltah Chashmah" actor Jennifer Mistry Bansiwal on Thursday accused producer Asit Kumar Modi and two others of sexual harassment, a charge they denied, claiming she was let go from the show due to misbehaviour.

Modi also said that he will take legal action against the actor for trying to defame him and the show. Bansiwal, who plays the role of Roshan

Sodhi on the long-running Sab TV show, said she sent a formal letter to the concerned authorities, including the National Commission for Women (NCW) and Mumbai Police on April 8, accusing Modi, project head Sohal Ramani and executive producer Jatin Bajaj of sexual harassment and outraging the modesty of a woman. According to a senior police officer at Powai police station, they received Bansiwal's application on May 8. Bansiwal claimed Modi "sexually harassed"

her on multiple occasions over the last few years. "He would pass uncharitable comments but I ignored them. In March 2019, in Singapore, he said many things like, 'Come to my room, let's have whisky'", she alleged. "I kept quiet but shared these things with two of my colleagues. They would often shield me. They are still working on the show, so they can't do much," the actor told PTI. She also claimed she told Ramani about her ordeal. "I told him, 'I don't want to work on the show.' He said, 'We will stop your payment for four months'. Mentally, they put pressure on me," Bansiwal added. Modi denied Bansiwal's allegations and said he will take legal action against her for trying to defame him and the show. "Since we terminated her services, she is making these baseless allegations," the producer told PTI. He also claimed Bansiwal was removed from the show on "account of misbehaviour".

"We were shooting on March 7 on Holi. Something happened and she misbehaved. We incurred a financial loss. The director and the production team said they will not work with her as she misbehaved and abused them. "They decided to remove her from the show. I was in the US when this incident happened. Once we removed her from the show, she started levelling allegations against us. We are in talks with our lawyers. They will decide the future course of action," Modi said. However, Bansiwal alleged that both Ramani and Bajaj misbehaved with her on the show's sets on March 7. In a media statement, Ramani and Bajaj denied the allegations, claiming Bansiwal regularly misbehaved with the entire team of the show. "We had to terminate her contract because of her bad behaviour and indiscipline during the shoot. During this incident, Asitji was in the US. She is now trying to defame us and the show by making baseless allegations. (PTI)
