### "PROCEEDINGS OF THE 07TH ANNUAL GENERAL MEETING OF NATURO INDIABULL LIMITED"

Ms. Rishibha Kasat, Company Secretary & Compliance Officer of the company presided over the meeting. The Company Secretary introduced and welcomed the Directors and Key Managerial Personnel, Chairperson(s) of the Audit Committee, Stakeholder and Relationship Committee, Nomination & Remuneration Committee to join her at the dais.
