**Auditor's Annual Compliance Certificate for Thadani Family Trust ("Trust") – NIIT Technologies Limited**

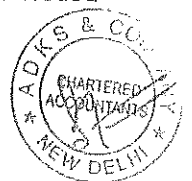
1. This Certificate is issued in accordance with the terms of engagement letter dated 5<sup>th</sup> April 2019.
2. As at 31 March 2019, Thadani Family Trust ("Acquirer") holds 2,175,911 shares of NIIT Technologies Limited, representing 3.52% stake in NIIT Technologies Limited.

### Opinion


