Sub: - Outcome of the meeting held today i.e., April 03, 2024, in respect of Conversion of warrants into Equity Shares (One Equity Share for one warrant issued)

This is to inform you that pursuant to the approval of Shareholders in their Annual General Meeting held on September 11, 2023, Board of the Directors of the Company had done allotment of convertible warrants on preferential basis to promoters and non-promoters on September 16, 2023, September 20, 2023 and September 21, 2023.

Further, we wish to inform you that the Board of Directors of the Company in the Board Meeting held today on April 03, 2024, considered and approved the conversion of 22,00,000 (Twenty Two Lakhs) warrants convertible into 22,00,000 (Twenty Two Lakhs) equity shares of face value of ₹ 10/- each, upon receipt of an amount aggregating to ₹ 4,12,50,000 (being 75% of the issue price per warrant) from the allottees (mentioned in *Annexure – I*) pursuant to the exercise of their right of conversion into equity shares in accordance with the Special resolution of the members dated September 11, 2023 and the provisions of the Companies Act, 2013 and the SEBI (ICDR) Regulations, 2018.

Consequent to aforementioned conversion of warrants and allotment of Equity Shares, 33,00,510 warrants of Dynamic Services & Security Limited (Promoter) and 45,99,490 warrants of non-promoters (public) remain pending for conversion.

Pursuant to the conversion, the Issued, Subscribed and Paid-up Equity Share Capital of the Company stands increased to ₹21,81,00,000/- (Rupees Twenty One Crores Eighty One Lakhs only) consisting of 2,18,10,000 (Two Crore Eighteen Lakh Ten Thousand) fully paid-up Equity Shares of ₹ 10/- each. The new equity shares so allotted shall rank pari-passu with the existing equity shares of the Company.
