The applications of drone technology in Karnataka's forests extend far beyond surveillance and poacher tracking. The center established by DroneAacharya at Dharwad will further serve as a nodal point for providing Drone services as well for surveying, 3D modeling, predictive analysis, anomaly detection, hotspot detection and surveillance.
