**Sub: Intimation under Regulation 30 of the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015, as amended ("SEBI Listing Regulations")**

This is further to our letter dated 15 November 2023, vide which the Company informed about the restriction by the Reserve Bank of India (RBI) on the sanction and disbursal of new loans under "eCOM" and online/digitally on 'Insta EMI Card'. Further, vide its letter dated 17 November 2023, the Company, informed temporary suspension of issuance of Existing Member Identification cards ('EMI cards') to new customers.

Now, we wish to inform that the RBI, vide its letter dated 2 May 2024, based on the remedial actions taken by the Company, has conveyed its decision of lifting the said restrictions on eCOM and online digital 'Insta EMI Card', with immediate effect.

The Company would now resume sanction and disbursal of loans in the above two business segments including issuance of EMI cards.

The Company remains committed to ensure adherence and compliance of regulatory guidelines.
